BOARD OF DIRECTORS MEETING SEPTEMBER 4, 2024

Approval to support consultation, training, resources, and professional learning opportunities for District and IU staff:

Approved a contract with Frontline Education to provide a professional learning management system to DCIU programs and member districts at a discounted consortium rate from July 1, 2024, to June 30, 2025.

Approved the 2024-2028 Gifted Equity Initiative Javis Grant from the Pennsylvania Department of Education to support DCIU serving as a regional liaison for gifted programming.

Approval of contracts with School Districts and other partners for programs and services:

Approved a contract with Garnet Valley School District for DCIU to provide Acadience training and up to 100 hours of Multi-Tiered System of Support (MTSS) consultation from August 22, 2024, to June 30, 2025.

Approved the following contracts with the School District of Haverford Township for DCIU to provide:

- Complex learner training and ongoing coaching from August 27, 2024, to May 31, 2025
- Wilson Reading Program Level I tutors for individual students and groups from September 1, 2024, to June 30, 2025.

Approved a contract with Southeast Delco School District for DCIU to provide English Language Development (ELD) instruction, assessment and professional development from September 1, 2024, to June 30, 2025.

Approved a contract with Springfield School District for DCIU to provide special education programming support from August 22, 2024, to May 31, 2025.

Approved a contract with County of Delaware, Department of Human Services (DHS), Office of Adult and Family Services to fund DCIU Family Centers services from July 1, 2024, to June 30, 2025.

Approved a contract with William Penn School District for managed security services from July 1, 2024, to June 30, 2025.

Approved contracts with Southeast Delco School District and William Penn School District to provide breakfast, lunch, and snack for students in the Pre-K Counts classrooms for 180 days from October 1, 2024, to September 30, 2025.

Approval for the following school districts to enter a memorandum of understanding with DCIU to form a Title III consortium from July 1, 2024, to September 30, 2025: Chichester, Garnet Valley, Haverford, Interboro, Penn-Delco, Rose Tree Media, Wallingford-Swarthmore.

Approval to enhance student learning and work experience and support future educators:

Approved a contract with The Pennsylvania Higher Education Assistance Agency (PHEAA) to reimburse DCIU for student teachers as part of the PA Student Teacher Support Program for the 2024-2025 school year.

Approved an agreement with Mercy Catholic Medical Center of Southeastern Pennsylvania to provide healthcare experiences to DCTS Medical Assisting students from September 1, 2024 to August 31, 2029.

Approval for up to 60 students and nine advisors to attend the SkillsUSA Fall Leadership Conference in Pocono Manor, PA from November 13, 2024, to November 15, 2024.

Approved the purchase and installation of four dental chairs with attachments from Henry Schein, Inc. for the Dental Occupations Program.
