BOARD OF DIRECTORS MEETING JANUARY 3, 2024

Approval to support training and professional learning opportunities for District and IU staff:

Approved a Memorandum of Understanding with Upper Darby School District for DCIU to provide licenses through Renaissance Learning for the administration of the Pupil's Attitudes for Self and School (PASS) assessment as part of the STOP Restorative Practices Grant from September 1, 2023, to September 30, 2025.

Approval of other grants, contracts, leases, purchases, appointments and services:

Approved the appointment of Dr. Andrew Babson, Radnor Township School District, to fulfill the term December 5, 2023, to June 30, 2025, to replace exiting Director Mr. Bradley Moore.

Approved the appointment of Ms. Bettie McClairén, Chester-Upland School District, to fulfill the term December 19, 2023, to June 30, 2025, to replace exiting Director Mr. Fred Green.

Approved the purchase of a Medit i700 scanner for the Dental Occupations Program, funded through the Supplemental Equipment Grant and other funding.

Approval of contracts with School Districts and other partners for programs and services:

Approved a contract with Southeast Delco School District for DCIU to provide Human Resources administrative support from January 2, 2024, to January 31, 2024.

Approval to enhance student learning and work experience and support future educators:

Approved agreements with The College of New Jersey for DCIU to provide student teaching, practicum, and field experiences for students in the School of Education and with Widener University for DCIU to provide field training experience for students in the Counselor Education Program.

Approved a student affiliation agreement with Riddle Surgical Center to provide observational experience to students in the Medical Careers Program from January 4, 2024, to January 3, 2025.
