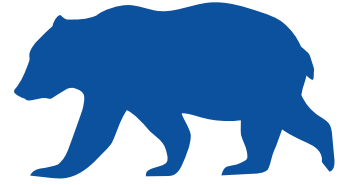

BREWER HIGH SCHOOL & MIDDLE SCHOOL GAME GUIDELINES

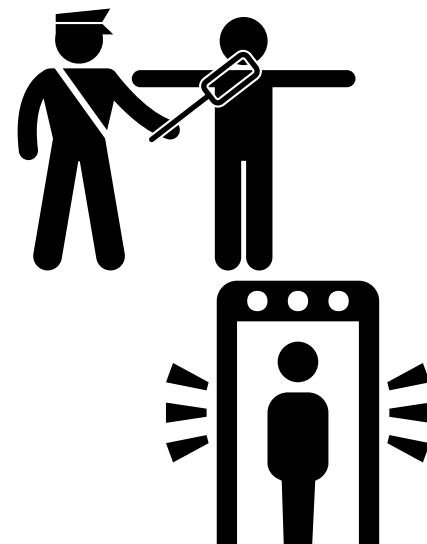
Brewer Middle School Students

All Brewer Middle School students and younger must be accompanied by a parent/guardian to be allowed entry at all BHS and BMS games.

Brewer High School Students

BHS students must provide a student ID to enter, and athletes are required to show their Athletic Pass.

Any student without the proper identification will not be permitted entry, unless they are accompanied by a parent/guardian who will be responsible for that student.

NOTICE OF NON-DISCRIMINATION
