This request for proposal (RFP) allows Region One Education Service Center and its Child Nutrition Program - South Texas Cooperative (CNP-STC) members the opportunity to purchase from Vendors, known as a company or firm, whose purpose is to provide kitchen equipment and small wares and related goods such as convection ovens, combi ovens, refrigerators, milk coolers, ice makers, freezers, heated cabinets, braising pans, microwave ovens, food dispensers, beverage dispensers, dishwashers, food storage containers, steam table pans, oven mitts, measuring cups, dishers, spatulas. Item descriptions, specifications and estimated quantities are provided for items. CNP-STC members are required to conduct a cost or price analysis for the procurement of goods not listed in the items tab, and within the scope of services offered with this bid solicitation. CNP-STC members are responsible for the selection of goods and/or services available to meet their needs, nutrition goals, storage capabilities, and student preferences.

On June 7, 2023, the Region One Education Service Center Purchasing Department, acting on behalf of its CNP-STC members, received eight (8) responses to Kitchen Equipment & Small Kitchen Wares RFP 23-0133.

On August 17, 2023, the Region One ESC Board of Directors met to review and approve the recommendations of the CNP-STC, acting on behalf of its members, for award of Kitchen Equipment & Small Kitchen Wares RFP 23-0133. Proposals were evaluated to select the best qualified vendors based on the established criteria. Eight (8) vendors were recommended for award. Vendors recommended for awarded had complete request for proposal submissions with an evaluation score of 70 or greater. CNP-STC Kitchen Equipment & Small Wares RFP 23-0133 effective August 1, 2023 through July 31, 2024, with the option to extend up to four (4) additional one-year periods if all parties are in agreement

On behalf of the CNP-STC membership, the current awarded vendors were offered the opportunity to utilize the first of four (4) one-year extension options for Kitchen Equipment & Small Kitchen Wares RFP 23-0133, effective August 1, 2024, through July 31, 2025 with three (3) one-year extension options remaining if all parties are in agreement. One (1) vendor, Pyramid Paper Company dba Pyramid School Products submitted a No Bid. Seven (7) vendors agreed to the extension option and were recommended for award.

On June 18, 2024, the Region One ESC Board of Directors met to review and approve the recommendations of the CNP-STC, acting on behalf of its members, for award of Kitchen Equipment & Small Kitchen Wares RFP 23-0133, Extension 1 of 4, effective August 1, 2024 through July 31, 2025 with three (3) one-year extension options remaining, if all parties are in agreement.
