Emily Davies made a motion to adopt the 2021-2022 School Calendar presented. Vickie Davidson seconded the motion and 7 members voted yes.

Shawn Coats made a motion to allow a maximum of \$566.85 towards Health Insurance Renewal costs for employees. Emily Davies seconded the motion and 7 members voted yes.

Larry Shoe made a motion to accept the bid from BSN for the Wellness Center Equipment at \$41,435.99. Shawn Coats seconded the motion and 7 members voted yes.

Emily Davies made a motion to approve the 3-year extension of the Mass Notification and District Website from Blackboard for a total of \$10,435.14. This would cover school years 2021-22, 2022-23 and 2023-24. Rachel Hunt seconded the motion and 7 members voted yes.
Emily Davies made a motion to approve the Speech Pathologist Agreement with dotcom Therapy for

the 2021-2022 school year at the amount of \$37,549. Terry Parker seconded the motion and 7 members voted yes.
