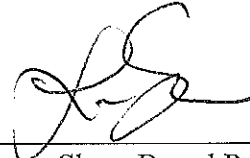

Larry Shoe made a motion for Executive Session per section 610.022 following the August 10, 2020,

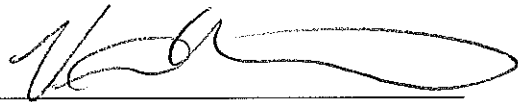
meeting. Shawn Coats seconded the motion and 4 members voted yes.
