Overview: Students will be participating in a field trip to the Alliance Theatre to see *The Chinese Lady*. The purpose of this trip is to provide students with more enrichment of being part of a live audience. Inspired by the true story of Afong Moy, The Chinese Lady is a darkly poetic yet whimsical portrait of our collective past through the eyes of a young Chinese woman. Afong Moy is only 14 years old when she's brought to the United States in 1834 and placed on public display as "The Chinese Lady" — thought to be the first to step foot on U.S. soil. Decade after decade, she performs as a living exhibit, showing curious white people how she eats, what she wears and — the highlight of the event — how she walks with bound feet. Time wears on, and eventually the lines between her performance and her own identity become blurry. Described as "moving and often sharply funny" (The New York Times), The Chinese Lady serves as an examination of the ongoing struggle for empathy and understanding across cultural divides.. RECOMMENDED FOR AUDIENCES AGES 12 AND UP. Students will meet in Ms. Jackson's Room at 8:30 am for attendance and bus.

Cost of Trip: \$27.00 on my school bucks link only (includes admission and reserved seat on the bus). Also, students will need to bring their lunch or pay **\$15** for lunch from Moe's Catering. If a student does not have funds or packed a lunch they can eat school lunch.
