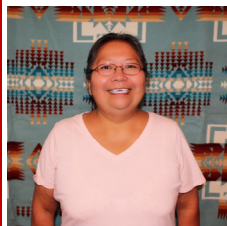

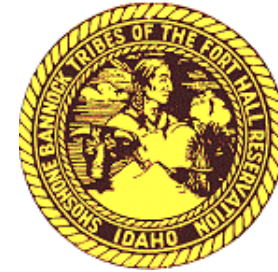

PROGRAM HISTORY

The Tribal Youth Education Program was created and implemented in the Fall of 2005 to address and identify educational issues affecting local American Indian youth in kindergarten through the twelfth grade.

JUSTIFICATION

Students need community support. Direct services and outreach are essential to address:

- ◆ Low academic performance
- ◆ Attendance problems
- ◆ High dropout rate
- ◆ Increase student retention and the graduation rate
- ◆ Increase student college and career preparedness
- ◆ Increase academic readiness



TRIBAL

RESPONSIBILITY

The Tribal Youth Education Program shall be responsible to the Shoshone-Bannock Tribes and the membership in its duty to deliver services to help youth attain measurable education outcomes.

MISSION STATEMENT

The mission of the Tribal Youth Education Program is to increase student ISAT scores, decrease student absenteeism, decrease the student dropout rate, increase high school graduation rates, and increase college preparedness of Indian students in this area.
