


The number of students that were enrolled in each school year.










Star Reading Current Student Growth Percentile (SGP) Fall to Fall 2024-2025



Star Math Current Student Growth Percentile (SGP) Fall to Spring 2022-2023




Star Math Current Student Growth Percentile (SGP) ⑦




Star Math Current Student Growth Percentile (SGP)⁽²⁾




