- 1. The Board makes a finding that good cause did not exist under Texas Education Code section 21.210 for Mariana Tejada's resignation of her probationary contract for the 2024-2025 school year;

- 3. Mariana Tejada has failed to perform her contract; and
- 4. The Board authorizes the Superintendent to file a complaint with the State Board of Education Certification to seek sanctions for her abandonment of her contract.
