Permission and Release of Liability

We stipulate that we are the Parent(s) and/or Legal Guardian(s) of the Student named above. The Parent(s) and/or Legal Guardian(s) recognize and acknowledge that the Student is a member of an athletic team sponsored by the Spring-Ford School District (“District”) and has been offered bus transportation by the District in order for the Student to participate in and attend away athletic contests involving said team. Athletes are to ride the bus to and from all away athletic contests, compete as a team, win or lose as a team, and travel as a team; however, exceptions can be made if warranted, but those exceptions should be minimized. As the result of the decision by the Parent(s) and/or Legal Guardian(s) under the circumstances, transportation, as offered by the District, is being waived. Athletes requesting an exception are required to bring written permission from their parent or guardian a day in advance of the athletic contest involving said team in the form of this completed “Permission and Release of Liability.” In addition, prior to departing the athletic contest, the athlete and his or her Parent(s) and/or Legal Guardian(s) must approach the head coach to notify the head coach of his or her departure. Athletes may only ride to/from the athletic contest with their own Parent(s) and/or Legal Guardian(s). **THE ATHLETE MUST STAY UNTIL THE CONCLUSION OF THE ATHLETIC CONTEST OR UNTIL EXCUSED BY THE HEAD COACH.**

Parent(s) and/or Legal Guardian(s) requested and District agrees to allow Parent(s) and/or Legal Guardian(s) to transport the Student from the athletic contests involving said team. Parent(s) and/or Legal Guardian(s) and Student hereby release, discharge and covenant not to sue the District, its Board members, administrators, teachers, employees, volunteers and agents, and other participants (each considered one of the "Releases" herein) from all liability, claims, demands, losses or damages on the Student's account, caused or alleged to be caused in whole or in part by the transportation of the Student by Parent(s) and/or Legal Guardian(s) from the athletic contests involving said team, and Student further agrees that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, Parent(s) and/or Legal Guardian(s), Student, or anyone on behalf of Parent(s) and/or Legal Guardian(s) and/or Student, makes a claim against any of the Releases, Parent(s) and/or Legal Guardian(s) will indemnify, save and hold harmless each of the Releases from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

Parent(s) and/or Legal Guardian(s) and Student acknowledge that they have read this Permission and Release of Liability, fully understand its terms, understand that they have given up substantial rights by signing it, and, intending to be legally bound, have signed it freely without inducement or assurance of any nature, and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law. Parent(s) and/or Legal Guardian(s) and Student further agree that if any portion of this Permission and Release of Liability is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

The District reserves the right to limit parent and/or legal guardian transportation as an option for certain away competitions at the discretion of the District.
