All students will receive high quality tier one instruction using evidence based practices for reading and math and students will receive targeted small group instruction based on individual needs and goals.

Magnet Lead teachers will lead professional learning in small group reading and math instruction with lesson study process and observations to improve Tier 1 instruction and facilitate meeting student outcomes.

Teachers will participate in professional learning in the science of reading.

Instructional Assistants to support students during small group instruction.

All English learners will receive leveled English Language Development (ELD) instruction focused on reading, writing, listening and speaking skills necessary to meet proficiency benchmarks in ELA and math as well as reclassify from English learner to Fluent English Proficient. ANALYSIS

There have been significant increases in student progress in reading based on authentic reading assessments with over 85% of students showing growth in their reading level. However, on the STAR assessment for both reading and math, there are a significant number of students who are not yet meeting benchmark standard for their grade level. The data would indicate a need to continue the present strategies while working toward improving the quality of instruction. Due to the inconsistencies of the testing conditions in spring of 2021 due to Covid restrictions, the assessment data for 2022 will be a stronger indicator of actual growth for the 2022-23 school year.

The majority of the expenditures continue to be in staffing for intervention or to support Tier 2 intervention in primary classrooms.

Due to an emphasis on reading intervention to support learning loss during the pandemic, math intervention was limited during the 2021-22 school year, There is a plan to increase math intervention for students performing significantly below grade level.

 - b. Be based on academic achievement information about all students in the school, including all groups under §200.13(b)(7) and migratory children as defined in section 1309(2) of the ESEA, relative to the State's academic standards under §200.1 to—
 - Help the school understand the subjects and skills for which teaching and learning need to be improved; and
 - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards; and
 - Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
 - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
 - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
 - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

Requirements for the Plan

- II. The SPSA shall include the following:
 - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.

- B. Evidence-based strategies, actions, or services (described in Strategies and Activities)
 - 1. A description of the strategies that the school will be implementing to address school needs, including a description of how such strategies will--
 - a. provide opportunities for all children including each of the subgroups of students to meet the challenging state academic standards
 - b. use methods and instructional strategies that:
 - i. strengthen the academic program in the school,
 - ii. increase the amount and quality of learning time, and
 - iii. provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
 - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
 - i. strategies to improve students' skills outside the academic subject areas;
 - ii. preparation for and awareness of opportunities for postsecondary education and the workforce;
 - iii. implementation of a schoolwide tiered model to prevent and address problem behavior;
 - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
 - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C.  - 2. Provide sufficient information on which to base effective assistance to those students.
- G. For an elementary school, a description of how the school will assist preschool students in the successful transition from early childhood programs to the school.
- H. A description of how the school will use resources to carry out these components (described in the Proposed Expenditures for Strategies/Activities).
- I. A description of any other activities and objectives as established by the SSC (described in the Strategies/Activities).

Additional Targeted Support and Improvement

A school identified for ATSI shall:

1. Identify resource inequities, which may include a review of LEA- and school-level budgeting, which will be addressed through implementation of its TSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities, and Annual Review and Update, as applicable).
