This is our starting point to meet the student where they are at in their academics. NVIS has students complete the district-wide Star Reading and Math assessments. NVIS provides high quality and equitable instruction aligned to grade level standards. With the results of all assessments, including the CAASPP, we are able to feel confident in knowing that we can help fill a child's academic gaps by giving them an individualized, unique curriculum to meet the high standards that will prepare them for college and careers. Students at NVIS benefit from strong social and emotional supports. As we plan for student success, goals are created that are aligned with LCAP goals, NVUSD Strategic Plan, WASC and Federal, State, and Local programs.

With the approval for AB130, we have seen an increase of students who need ELD support in our program. We have also added TK-3rd grades. Students will need foundational supports and daily support for ELs to be able to access curriculum and improve their progress in reading and math. We will use the data from the STAR assessments to help us understand where the gaps are for students and how to improve their gaps in learning.

With the pandemic we have students who have not progressed to their full potential due to distance learning and lack of connection to school. The big difference for NVIS is we will continue to conduct distance learning for those families that have concerns about their children being at school in person. We will have to evaluate student progress and be strategic with the Learning Hubs designed for one:one or small group support.

Many students come to NVIS needing to make up graduation requirements. We are also the only option for distance learning for those families who do not feel comfortable sending their students back to in-person learning at school. Students will need additional supports in their online curriculum that will be engaging to drive their learning. Students are assigned an Advisory Teacher. The Advisory teacher will manage all the courses each student needs to meet graduation requirements.

Teachers will be assigned caseloads of students and will be assigning them work in all of their core subjects. This will have teachers working in content areas outside of their expertise. This is a response to the passing of AB130 and the increased number of students in our program who want a virtual learning option because of concerns of being in person at school.

With the increase of enrollment of students from TK-12th grades, there will be a need for parents to understand the NVIS community as new members. We want to improve our connectedness to school after a year of distance learning and have opportunities for students to engage with each other and staff. We also need to bring back the opportunities for our students to understand the options in regards to college and career exploration.

Due to the self-referral process at the start of 2021-2022 school year, students and families were not able to receive critical information on how the NVIS environment functions from their home school. Although each family had to attend a virtual orientation prior to enrollment, there was no opportunity for NVIS staff to personally connect with each family. This gap has created a disconnect between school and the families.

NVIS last year had the highest percentage of students who scored in the red or yellow on the fall administration of the SDQ. We are now the only option for online learning. Students are signing up to join our program because parents are concerned about in-person learning during the pandemic. That will bring some anxiety and/or social emotional needs to be addressed so students can access their learning to their full potential.

NVUSD offered the online learning for families concerned with COVID-19 unfortunately many virtual students are struggling and not making much academic progress.

The changes for the 2022-2023 school year will be that any family wanting to attend NVIS will need to meet with their home school Counselor. 

 - i. Help the school understand the subjects and skills for which teaching and learning need to be improved; and
 - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards; and
 - iii. Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
 - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
 - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
 - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

Requirements for the Plan

 - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.

 - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
 - i. strategies to improve students' skills outside the academic subject areas;
 - ii. preparation for and awareness of opportunities for postsecondary education and the workforce;
 - iii. implementation of a schoolwide tiered model to prevent and address problem behavior;
 - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
 - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
