Schoolwide Program

Phillips is a school-wide Title 1 Magnet school. As such, the Phillips staff and community are committed to providing a high-quality educational experience for all students. Students receive instruction in the core subjects of English Language Arts and Math using district-adopted programs. In addition, Phillips students receive magnet-themed instruction, with project-based learning as the primary vehicle for this learning integrated into their core subjects. Magnet theme units include instruction in science and social studies with our magnet theme "leadership, engineering and art design" woven into each unit to enhance the students' experiences. Since Phillips has a high percentage of English language learners, both integrated English Language Development as well as designated English Language development are key drivers in planning both core and magnet-themed instruction. Grant funding, including the Magnet Grant and the Cowell Grant, is used to

support professional development and coaching to support ELA, Math, and magnet-themed instruction.

This year the Leadership team at Phillips (comprised of lead teachers from each grade level as well as the Principal, Intervention teacher, Magnet Lead teacher, and Magnet Coach) read and reflected on the book Equitable Access for English Learners by Mary Soto. The Leadership team shared strategies with the staff during Teacher Learning meetings.

Due to subbing shortages, teachers did not receive professional development with Designated and/or Integrated ELD practices.

We found that our students were much more prepared for the ELPAC testing in the Spring when teachers used a "Boot camp" style prep for each grade level. Next year, we would like to align the ELD "boot camp" with our Magnet-themed units and teach them throughout the year rather than just right before the ELPAC testing.

Once schools opened up more to parents and volunteers on campus in the Spring, we noticed more parent involvement with attending Cafecitos (coffee with the Family Resource Center and Principal), as well as Open House and an end-of-the-year Phillips Family Fun Night in which we saw almost 400 people attend.

 - b. Be based on academic achievement information about all students in the school, including all groups under §200.13(b)(7) and migratory children as defined in section 1309(2) of the ESEA, relative to the State's academic standards under §200.1 to—
 - Help the school understand the subjects and skills for which teaching and learning need to be improved; and
 - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards; and
 - Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
 - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
 - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
 - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

Requirements for the Plan

- II. The SPSA shall include the following:
 - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.

- B. Evidence-based strategies, actions, or services (described in Strategies and Activities)
 - 1. A description of the strategies that the school will be implementing to address school needs, including a description of how such strategies will--
 - a. provide opportunities for all children including each of the subgroups of students to meet the challenging state academic standards
 - b. use methods and instructional strategies that:
 - i. strengthen the academic program in the school,
 - ii. increase the amount and quality of learning time, and
 - iii. provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
 - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
 - i. strategies to improve students' skills outside the academic subject areas;
 - ii. preparation for and awareness of opportunities for postsecondary education and the workforce;
 - iii. implementation of a schoolwide tiered model to prevent and address problem behavior;
 - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
 - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C. Additional Targeted Support and Improvement
