With all the collective input, a draft was created to bring to the SSC for approval. Updates on actions and progress toward goals are reviewed at each SSC meeting. The site Council meeting was held on June 6, 2022, to approve this plan.

### **Identified Need**

At Vichy Elementary school, a majority of our students scored at or above the benchmark on the STAR Math and Reading assessments at EOY 21-22. Our focus will be on implementing strategies and interventions that will target students at VES to show a year's growth in a year.

#### Activities

Teachers will participate in Professional Learning Communities (PLC) twice per month. The team will gather and review data to determine students who did not make standard growth in the previous year. They will also consider an area of focus based on the data; Math or Reading. PLCs

will determine learning targets to meet the needs of these students. Our kindergarten students will participate in an early/late schedule to support small group instruction on early literacy skills. Our first through fifth-grade students will work in small groups with teachers to target specific learning needs. Teachers will use common assessments and work through the PLC cycle of inquiry, utilizing learning sprints to target specific skills. Teacher stipend or sub-release time will be used for planning instruction.

Teacher stipend for non-contract work day for planning instruction.

# ANALYSIS

In 2021-22, PLCs met consistently to support student learning through looking at data and planning instruction. With a number of combination classes across all grade levels, PLCs were designed to

have access to both grade levels in most cases. Teachers were effective in providing small group instruction and in the learning academy sessions.

Briefly describe any major differences between the intended implementation and/or the budgeted expenditures to implement the strategies/activities to meet the articulated goal.

Learning academy started later in the year so that we could give students and teachers time to adjust to being back at school and provide students an opportunity to engage in learning in a more traditional way. Some students had not been in a classroom for a year and a half. This time allowed for adjustment socially, emotionally, and educationally and provided teachers with an opportunity to evaluate the learning needs of their students.

In 2022-23, we will continue to focus on growth for all students. The Learning Academy model may be implemented differently, and staff will have additional time for the preparation of the curriculum to meet the needs of all students. We will continue to utilize learning sprints throughout the year to focus on specific skills. Those students who are scoring below the benchmark will also receive support through additional intervention instruction.

As the number of ELL students increases at Vichy, we see the need to bring the families of these students into the decision-making process along with wanting them to be active participants in our school community. Since our ELAC was established in 2020-21, we are still building our participation level with parents. During COVID, parent involvement was challenging. Our parent liaison is a point of contact for our EL families and she reaches out to remind them of our meetings as well as support them with any other needs.

We did see some challenges this year and look forward to adding to the support provided to students. With the addition of the "tools" taught in the Toolbox Project, students have opportunities to build their capacity to handle challenging situations not only at school but in any environment. Incorporating the situational examples and lessons in the new Digital Second step will further develop these skills in our students. The MTSS team and staff are committed to working together to support students' needs. By providing sub-release time, teachers can be involved in IEP meetings to implement instructional plans as well as support providers and families with insights into how the students are performing in the classroom. This team approach builds a community of support for our students with IEPs.

We did not have any major changes to our intended use of Toolbox this past year. All classrooms instructed students on the tools and continued to review them throughout the year.

# **Appendix A: Plan Requirements**

### Schoolwide Program Requirements

This School Plan for Student Achievement (SPSA) template meets the requirements of a schoolwide program plan. The requirements below are for planning reference.

A school that operates a schoolwide program and receives funds allocated through the ConApp is required to develop a SPSA. The SPSA, including proposed expenditures of funds allocated to the school through the ConApp, must be reviewed annually and updated by the SSC. The content of a SPSA must be aligned with school goals for improving student achievement.

### **Requirements for Development of the Plan**

- I. The development of the SPSA shall include both of the following actions:
  - A. Administration of a comprehensive needs assessment that forms the basis of the school's goals contained in the SPSA.
    - 1. The comprehensive needs assessment of the entire school shall:
      - a. Include an analysis of verifiable state data, consistent with all state priorities as noted in Sections 52060 and 52066, and informed by all indicators described in Section 1111(c)(4)(B) of the federal Every Student Succeeds Act, including pupil performance against state-determined long-term goals. The school may include data voluntarily developed by districts to measure pupil outcomes (described in the Identified Need); and
      - b. Be based on academic achievement information about all students in the school, including all groups under §200.13(b)(7) and migratory children as defined in section 1309(2) of the ESEA, relative to the State's academic standards under §200.1 to
        - i. Help the school understand the subjects and skills for which teaching and learning need to be improved; and
        - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards; and
        - iii. Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
        - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
        - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
  - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

### **Requirements for the Plan**

- II. The SPSA shall include the following:
  - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.

- B. Evidence-based strategies, actions, or services (described in Strategies and Activities)
  - 1. A description of the strategies that the school will be implementing to address school needs, including a description of how such strategies will-
    - a. provide opportunities for all children including each of the subgroups of students to meet the challenging state academic standards
    - b. use methods and instructional strategies that:
      - i. strengthen the academic program in the school,
      - ii. increase the amount and quality of learning time, and
      - iii. provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
    - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
      - i. strategies to improve students' skills outside the academic subject areas;
      - ii. preparation for and awareness of opportunities for postsecondary education and the workforce;
      - iii. implementation of a schoolwide tiered model to prevent and address problem behavior;
      - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
      - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C. Proposed expenditures, based on the projected resource allocation from the governing board or body of the local educational agency (may include funds allocated via the ConApp, federal funds for CSI, any other state or local funds allocated to the school), to address the findings of the needs assessment consistent with the state priorities, including identifying resource inequities, which may include a review of the LEAs budgeting, it's LCAP, and school-level budgeting, if applicable (described in Proposed Expenditures and Budget Summary).   - 2. Provide sufficient information on which to base effective assistance to those students.
- G. For an elementary school, a description of how the school will assist preschool students in the successful transition from early childhood programs to the school.
- H. A description of how the school will use resources to carry out these components (described in the Proposed Expenditures for Strategies/Activities).
- I. A description of any other activities and objectives as established by the SSC (described in the Strategies/Activities).

### **Comprehensive Support and Improvement**

The LEA shall partner with stakeholders (including principals and other school leaders, teachers, and parents) to locally develop and implement the CSI plan for the school to improve student outcomes, and specifically address the metrics that led to eligibility for CSI (Stakeholder Involvement).

The CSI plan shall:

- Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable);
- Include evidence-based interventions (Strategies/Activities, Annual Review and Update, as applicable) (For resources related to evidence-based interventions, see the U.S. Department of Education's "Using Evidence to Strengthen Education Investments" at https://www2.ed.gov/policy/elsec/leg/essa/guidanceuseseinvestment.pdf);
- 3. Be based on a school-level needs assessment (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable); and
- 4. Identify resource inequities, which may include a review of LEA- and school-level budgeting, to be addressed through implementation of the CSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities; and Annual Review and Update, as applicable).

### **Additional Targeted Support and Improvement**

A school identified for ATSI shall:

 Identify resource inequities, which may include a review of LEA- and school-level budgeting, which will be addressed through implementation of its TSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities, and Annual Review and Update, as applicable).

### Single School Districts and Charter Schools Identified for School Improvement

Single school districts (SSDs) or charter schools that are identified for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (EC Section 64001[a] as amended by Assembly Bill [AB] 716, effective January 1, 2019).
