There is a disproportionate rate of chronic absenteeism among students with disabilities. Students with disabilities qualify for additional targeted support and improvement in ELA and math.

### Involvement Process for the SPSA and Annual Review and Update

The draft SPSA was codeveloped by the principal and site leadership team and shared with teaching staff for input. Starting at the April leadership and SSC meetings, the team used the SWIFT FIA document to identify strengths and growth areas and began working on goals for the 23-24 school year. The draft goals & document is shared with the English Learner Advisory Committee and the School Site Council for input and approval. Updates on actions and progress toward goals are reviewed at each SSC meeting as well as at leadership team meetings, MTSS meetings, and staff meetings as appropriate.

## Resource Inequities

Willow Elementary School has been identified as an Additional Targeted Support and intervention (ATSI) school site. The resource inequities identified by reviewing and analyzing student data are as follows: Our students with disabilities are experiencing higher levels of chronic absenteeism than our overall student population. Students with disabilities have performed significantly below our overall students on the CAASPP in ELA and math. Supplemental funding will be targeted to support improved outcomes for this identified student subgroup as described in our action plan.

Willow made significant growth in both math & reading based on the STAR data. At or above grade level In Reading from 2022-2023: 2nd grade from 27 - 50%; 3rd grade from 45 - 54%; 4th grade from 28 - 59% and 5th grade from 50 - 54%. In math: 1st grade from 31 - 73%; 2nd grade from 22 - 63%; 3rd grade 27 - 65%; 4th grade from 27 - 65% and 5th grade from 19 - 66%. This growth happened as a result of having students in school full time as well as very targeted intervention groups. We served over f00 students this year. By implementing even more structured systems for progress monitoring, we believe we can show this growth or better again this coming year.

We were able to purchase intervention materials and provide training to our teachers. We improved both the first instruction as well as intervention. Using district intervention dollars, we were able to add additional intervention for our K-1 students to support early intervention. This was implemented in November-March. This gave these younger students an additional boost.

We will continue to monitor our intervention students but will look at high-growth data and will tighten up our progress monitoring.

The school may include data voluntarily developed by districts to measure pupil outcomes (described in the Identified Need); and
      - b. Be based on academic achievement information about all students in the school, including all groups under §200.13(b)(7) and migratory children as defined in section 1309(2) of the ESEA, relative to the State's academic standards under §200.1 to—
        - i. Help the school understand the subjects and skills for which teaching and learning need to be improved; and
        - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards; and
        - iii. Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
        - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
        - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
  - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

### Requirements for the Plan

- II. The SPSA shall include the following:
  - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.



- B. Evidence-based strategies, actions, or services (described in Strategies and Activities)
1. A description of the strategies that the school will be implementing to address school needs, including a description of how such strategies will--
    - a. provide opportunities for all children including each of the subgroups of students to meet the challenging state academic standards
    - b. use methods and instructional strategies that:
      - i. strengthen the academic program in the school,
      - ii. increase the amount and quality of learning time, and
      - iii. provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
    - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
      - i. strategies to improve students' skills outside the academic subject areas;
      - ii. preparation for and awareness of opportunities for postsecondary education and the workforce;
      - iii. implementation of a schoolwide tiered model to prevent and address problem behavior;
      - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
      - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C. ## **Additional Targeted Support and Improvement**

A school identified for ATSI shall:
