viii. **Approve Teacher Teaching out of Endorsement**

Shon Schaffran, 5-8 ALE Teacher, will be rotating between English, Science and Math Professional Learning Communities (PLC's) attending one each Monday AM. Shon will be meeting with content area staff in person or through email to know what concepts are being taught for the week so he can match what he is doing with ALE students. Each Friday at 2:00 Shon will meet with an ALE committee person(s) regarding: Curriculum, How classes are going, Parent/Student weekly meetings and meeting with content area teachers during their plan time.

Out of Endorsement Area Course Assignment School district response and support for non-matched endorsements to course assignment of teachers is outlined in WAC 181-82-110. According to the WAC, individuals with initial, residency, endorsed continuing, or professional teacher certificates who are employed with a school district under RCW 28A.405.210 may be assigned to classes other than in their areas of endorsement. If teachers are so assigned, the following shall apply:

1. A designated representative of the district and any such teacher so assigned shall mutually develop a written plan for a reasonable amount of planning and study time associated specifically with the out-of-endorsement assignment;
2. Such teachers shall not be subject to nonrenewal or probation based on evaluations of their effectiveness in the out-of-endorsement assignments;
3. Such teaching assignments shall be approved by a formal vote of the local school board for each teacher so assigned.
