School Facility Conditions and Planned Improvements

General cleanliness and upkeep is considered important for the overall pride and comfort of the students at their school. The school building, storage structures, playgrounds, and all areas of the school grounds consistently receive exemplary reports regarding maintenance, condition, and cleanliness. When safety issues do arise, they are addressed immediately when possible and always within a reasonable amount of time. Due to our exemplary maintenance staff, no issues were noted this year. General maintenance and cleaning are conducted by designated staff persons as needed. The current maintenance staff person maintains the classrooms, as well as on the school grounds, and places a priority on the areas that have the most direct impact on the health and safety of students and staff. The floors are waxed regularly and the carpets are professionally cleaned once a year. Restrooms are sanitized three times a week, repairs to indoor and/or outdoor items are made immediately once a problem is noted, and clearing the dry overgrowth around the perimeter of the grounds has been made a priority in order to reduce fire hazards in dry months. A log has been created to track cleaning and school maintenance. The COVID-19 pandemic has increased the need for regular sanitation of high-touch surfaces, which has been accomplished through an "all hands on deck" approach with classroom staff and maintenance staff working together to keep the school safe for students and staff.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

Options

Note that the CAAs could only be administered in-person following health and safety requirements. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;

- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

Parents are given many opportunities to be involved in the educational process of their child/ren. They are highly encouraged to participate inside the classroom whenever and wherever possible, including volunteering in class and assisting as chaperones for field trips. A weekly newsletter, the Tuesday Telegram, is provided to keep families up to date with the latest information regarding general school activities. It is provided in their preferred language and delivery style (online or hard-copy). Monthly Board meetings are announced several days in advance and the agenda is posted in a public area to give all interested parties an opportunity to attend. Family members are encouraged to run for office when a position on the Board of Trustees is available. Parents are also encouraged to take part in the School Site Council and to provide their input at the applicable meetings. As the needs arise, everyone is invited to assist with a "Community Work Day." These are scheduled to address any minor maintenance issues that could use some attention and to build a stronger sense of community and ownership among the families. As per LCAP & LCFF funding parameters, a survey is presented to all stakeholders (including all students and their families) at least once a year to request feedback on perceived needs of the school and/or suggestions to improve services.

2021-22 School Safety Plan

A comprehensive, yet streamlined, Safety Plan for Cienega School has been developed and is available in the main office of the school, as well as at the County Office of Education. The 2021-2022 Safety Plan includes a comprehensive safety plan for the COVID-19 pandemic. The safety plan was presented to the School Site Council in September 2021 and approved at the October 5, 2021 Board of Trustees meeting.

Fire drills are being each month and on-site extinguishers are visually inspected for any damage and to confirm they are fully charged. Extinguishers are also professionally serviced once a year. Quarterly earthquake drills, including participation in the "California Shake-Out" (statewide earthquake drill) each October, are conducted, as are quarterly "intruder" drills. The latter are designed with sensitivity toward students with anxiety issues, while still helping staff and students be better prepared in the event of any outside intruder alert (including wild animals) and/or other lock-down situations. Monthly safety meetings are held with the staff at the school and additional on-line safety courses are offered through the insurance carrier's website.

The Principal assesses the upkeep of the school using the Facilities Inspection Tool (FIT), and Keenan & Assoc. conducts an annual safety inspection. No major issues have been noted recently, though any small issues were addressed immediately and were resolved to the satisfaction of the Keenan reviewer. At all times, all necessary cleaning, maintenance, and repairs are addressed immediately.

Notices regarding health issues in the community and/or vaccination opportunities are distributed to the families as soon as the information becomes available. There is a strict disciplinary structure in place to assure that any disruptive, dangerous, or hurtful actions or words will not be tolerated.

Professional Development

There are no days dedicated specifically to staff development. The staff members are not required to take any additional courses. Certificated staff attend training sessions and/or conferences on their own time when, and if, they feel the information will enhance their ability to do their jobs more effectively and/or more efficiently. An additional benefit to the staff is often the opportunity to collaborate with other educators, which does not happen as often in such a small setting. Registration for these courses and any additional out-of-pocket expenses, are paid for by the school with School Board approval. Although the teachers make every effort to attend applicable courses on evenings, weekends, and holidays, substitute teachers are made available whenever necessary for the staff to attend a training during the school day.

In addition, the teacher/principal attends monthly rural principal meetings and trainings. In 2020-2021, staff trainings have been focused on reaching students during the COVID-19 pandemic, specifically with distance learning. Both upper and lower grade teachers have attended trainings on creating effective online classroom communities, building a user friendly Google classroom, and on COVID-19 specific trainings, as needed. The certificated staff members also attended the California Math Council conference virtually in 2020. On-line safety training courses are also completed by all the staff, as offered and directed by Keenan and Associates.
