2021-22 School Overview

Pinnacles Community School is operated by the San Benito County Office of Education. The staff believes all students can learn, given high expectations. Education is a shared responsibility which includes parents, students, staff, and the community. The mission of Pinnacles Community is to provide students with a safe and positive learning environment with modern resources and accommodations necessary to learn. The goal is to educate all students to their highest potential, so they will have the greatest range of personal options upon graduation. It is the 21st century vision of the San Benito Alternative Education sites to deliver meaningful, accessible curriculum through multiple avenues in a safe, supportive, and positive learning environment. With the help of our entire school community we will empower our students by developing the necessary skills needed to join our complex world as an engaged citizen.

Pinnacles Community School serves youths in grades 7-12. Students with probationary status who attend are admitted based upon of the following criteria: referral by San Benito County Juvenile Court School; referral by another school district when the student has been unsuccessful; expulsion from a school district; recommendation from the San Benito County Student Attendance Review Board (SARB) for habitual truancy; when a student moves to San Benito County and had been attending a community day school in their previous county of residence.

The school population is highly mobile. Average daily enrollment for Pinnacles Community School is approximately 5-15 students.

Teachers at Pinnacles Community School consistently align their curriculum maps, lessons, and formative assessments to the Common Core State Standards to achieve positive classroom results. Pinnacles Community teaching staff provide core academic courses in English Language Arts (ELA), Algebra Readiness, Algebra, Geometry, History/Social Science, and Science. In addition, migrant education and special education services are available. Each student in class has the use of a Chromebook to access online coursework, conduct research and create papers and presentations. Each student is assessed in English and Math.

Personal and/or crisis counseling is provided by the school counselor, School Social Worker and San Benito County Behavioral Health. The principal and various other staff members provide additional mentoring and coaching in the areas of communication, grades, and social development. Pinnacles also uses Restorative Justice (RJ) and is in the process of fully developing this program, as well as Positive Behavioral Interventions and Supports (PBIS).

2021-22 School Overview

Pinnacles Community School provides a safe, organized, and supportive environment that offers challenging appropriate opportunities for each student, thereby promoting equity and diversity. It fosters the academic achievement of all students, while developing the vocational and interpersonal skills required for success in a rapidly changing and technological world. The staff of the Community School instills a strong work ethic and respect for the community effort, while preparing students for active and productive roles in society as adults.

2021-22 Opportunities for Parental Involvement

The school leadership encourages parental and community involvement initially through the student enrollment orientation process, in which the principal or counselor meets with each family prior to the student attending school. Several members of the Pinnacles Community School staff are bilingual in English and Spanish and can communicate in the home language of many of the students. Newsletters and bulletins are developed and mailed home in both English and Spanish. Community resources that support students' physical, emotional and social well being are available to both students and parents. The school also has developed a resource database of parent and community supporters to assist students in their academic achievement and career aspirations.

Through the student information system, Aeries.net, parents are able to access student information online through a "Parent Portal". Instructions on how to set up an account are provided to the parents. Students also use the Edgenuity platform for credit recovery and initial instruction for electives and specific core content that is not offered in Pinnacles' master schedule, ie: Chemistry or Calculus. In addition, parents are encouraged to be part of the School Site Council and attend activities such as Back-to-School Night.

2021-22 School Safety Plan

Pinnacles staff provides a safe, orderly and supportive environment for students. The school is now adjacent to (but separated from) the campus that houses other SBCOE educational programs. This location allows for greater supervision of, and support to, students and teaching staff. Teaching staff are aware of and abide by school safety procedures as outlined in the School Safety Plan. Daily safety procedures have been put in place based on student needs. These include escorted restroom visits, counting of supplies, visual contact of minors at all times, student movement standards, and protocols for speaking with staff, etc.

The School Safety Plan is reviewed and updated annually, this year this occurred on January 20, 2021. Each year, an in-house inspection and reporting process is conducted. Every year a Workman's Compensation Inspection is conducted, as well as a Fire Safety Inspection. Various drills are held throughout the year, including fire drills, earthquake drills, and lock-down drills. Moreover, staff participate in a monthly Five-Minute Safety Lesson. All staff must complete online safety training modules from Keenan Safe Schools.

Professional Development

The Administrator of San Benito Alternative Education programs, SSC/DSLT, and San Benito County Office of Ed Services determine the professional development plan based upon a variety of information gathered from student achievement data and curricular needs. Deeper understanding of professional development needs are acquired during weekly staff meetings, weekly professional development, classroom observations, and staff evaluations.

Each Thursday is a student early release day. The early release schedule facilitates the attendance of all alternative education staff members for this weekly professional development. Each week a targeted development focus is prepared for teachers and staff. In addition, alternative education teachers have the opportunity to participate, free of cost, in San Benito County Office of Education's monthly professional development events, which include Social Emotional training and workshops, English Learner professional development and teaching in a block schedule format. Additional optional training was held prior to the school year starting that focused on curriculum development and teaching in a block schedule.

2021-2022 Professional development goals have continued social emotional strategies, trauma-informed practices, Restorative Justice, and continued implementation of PBIS. Continued training has been provided for the Google Classroom platform and extensions, and engagement strategies.

2020-2021 Professional development goals have continued trauma-informed practices, Restorative Justice, and continued implementation of PBIS. Due to COVID, training has been expanded to include tools for distance learning, including the Google Classroom platform and extensions, and engagement strategies.

2019-2020 Professional development goals continue trauma-informed practices, Restorative Justice, and creation/implementation of PBIS.

2018-2019 Professional development goals included student engagement strategies, Restorative Justice, and creation/implementation of PBIS.
