NEW 40 point Reading Renewal Requirement





WHO NEEDS TO DO THIS

(Certificates expiring 6/30/2025 and after)

The requirement applies to anyone with the following Certification coverages regardless of job title:

- Elementary Education (K-6)
- Prekindergarten/Primary Education (age 3 through gr. 3)
- Elementary Education (grades 1-6)
- Primary Education (grades K-3)
- · English (grades 1-6)
- Middle Grades English (grades 5-9)
- · Middle Grades Integrated Curriculum (grades 5-9)
- English (6-12)
- Reading (K-12)
- · Reading (Endorsement)
- English for Speakers of Other Languages (ESOL K-12) NOT REQUIRED FOR ESOL ENDORSEMENT
- Exceptional Student Education (K-12)



In the use of explicit, systematic, and sequential approaches to reading instruction, developing phonemic awareness, and implementing multisensory intervention strategies

Approval of coursework is at the discretion of districts within their professional learning catalog.

A total of 40 points is required (some courses do not total 40, but can be used towards the total of the 40 points)

Some courses satisfy the 20 point SWD requirement and counts towards the 40 points required for reading.

This requirement must be satisfied for every renewal starting with 6/30/2025 and after.

Failure to earn the 40 points required for reading will result in the certification coverage being deleted from your certificate or it could prevent your professional certificate from being renewed.

The Reading Renewal points must be earned during current validity period (ex. 7/1/2020-6/30/2025) or within the previous validity period (7/1/2015-6/30/2020). In other words, hours earned within 10 years of renewal must be used for the requirement. Coursework used to earn a certificate or endorsement may be used to renew it.
