## Instructions for Obtaining and Authenticating your Criminal Background Check

All newly hired US faculty and staff are required to have a FBI Criminal Background Check (CBC) completed and authenticated prior to arriving in Kuwait. In all cases your CBC must be authenticated. Proof of authentication is required prior to departing from the US, as legal residency and work permits cannot be obtained without such authentication. All Steps below can be completed by mail if necessary.

### Section A

#### STEP ONE

Identification Record Request/Criminal Background Check can be obtained by following the steps in this link.

#### STEP TWO

Transmit the documents obtained in **Steps 1** above to the State Notary Public Administrator for application of the State seal. The State Notary Public Administrator will affix a state authentication certificate.



#### STEP THREE

Transmit the documents obtained in Steps 1 and 2 above to the Authentications Office of the Department of State Notary Public Administrator following their instructions contained on their website at [www.state.gov/m/a/auth/](http://www.state.gov/m/a/auth/)

The Authentications Office will provide a certificate.

## STEP FOUR

In order to obtain the authentication of the US Department of State Seal at the Kuwait Embassy, transmit the documents obtained in **Steps 1 and 3** above (Before you send the documents from steps 1 and 3 to the Kuwait Embassy please contact the HR department at ABS and await our reply – [hr@abs.edu.kw](mailto:hr@abs.edu.kw)). You will also need to include, original and copy of CBC, a copy of your passport, Cover letter from applicant stating the purpose for authentication and the applicant contact information, Letter from us stating the purpose for authentication and our contact information (we will send this to you at the appropriate time) and self-addressed postage paid envelope. The fee is \$25.00 per document paid by money order. (See enclosure 1)
