- \*(6) Ensure that state and national curriculum standards, assessment programs, district programs, and instructional practices are aligned.
- \*(7) Prepare an annual calendar for instructional service activities.
- \*(8) Assist in the acquisition of appropriate teaching materials, textbooks and equipment.
- \*(9) Oversee Professional Development-MIP, MPO, Planning, Delivery, Follow-up, & Evaluation.
- \*(10) Coordinate the accreditation process.
- \*(11) Supervise the implementation of the Student Progression Plan.

- \*(34) Interpret programs, philosophy, and policies of the district to staff, parents, and the community.
- \*(35) Keep supervisor informed of potential problems or unusual events.
- \*(36) Maintain communication with other agencies and school districts to share and receive information about effective programs and practices.
- \*(37) Use effective, positive interpersonal communication skills.
- \*(38) Coordinate planning with other agencies.
- \*(39) Coordinate programs with the community college.
- \*(40) Develop, maintain, and enhance school-community relations and provide liaison among schools and school communities.
