JOB DESCRIPTION

QUALIFICATIONS:

- (1) Master's degree in Educational Leadership with a Valid Florida certification in Educational Leadership, Administration and Supervision, School Principal or Professional School Principal; with three (3) years successful educational experience Or
- (2) A Master's Degree in Human Resources from an accredited educational institution with three (3) years successful experience in personnel management or human resources development.
- (3) Satisfactory criminal background check and drug screening.

KNOWLEDGE, SKILLS AND ABILITIES:

Knowledge of Florida Administrative Code, federal rules and regulations governing the employment process and equal employment opportunity. Knowledge of the collective bargaining process and related statutory, regulatory and contractual requirements. Ability to communicate orally and in writing, using high level interpersonal skills. Ability to handle department budget and finances. Knowledge of personnel management.

PERFORMANCE RESPONSIBILITIES:

Service Delivery

- *(1) Direct and coordinate the planning, implementation and evaluation of the district's comprehensive personnel management system.
- *(2) Conduct employment interviews, exit interviews and other conferences.
- *(3) Coordinate teacher recruitment efforts.
- *(4) Oversee and monitor the affirmative action program.
- *(5) Assist in wage and salary plan development.
- *(6) Coordinate and monitor all personnel application processes.
- *(7) Oversee the personnel records system.
- *(8) Facilitate coordination between essential departments (payroll, finance, risk management, educational technology) for the purpose of providing quality service to all employees and applicants with Bradford County Schools.

DIRECTOR OF HUMAN RESOURCES (Continued)

- *(9) Assist instructional and support staff to resolve personnel issues.
- *(10) Counsel personnel.
- *(11) Assist supervisors to resolve personnel problems.
- *(12) Conduct orientation program for new employees.
- *(13) Conduct substitute teacher training.
- *(14) Prepare annual personnel renewal list for Board approval.

Inter/Intra-Agency Communication and Delivery

- *(15) Interact with parents, outside agencies, businesses and the community to enhance the understanding of district initiatives and priorities and to elicit support and assistance.
- *(16) Respond to inquiries and concerns in a timely manner.
- *(17) Keep supervisor informed of potential problems or unusual events.
- *(18) Serve on district, state or community councils or committees as assigned or appropriate.
- *(19) Provide oversight and direction for cooperative planning with other agencies regarding areas of responsibility.
- *(20) Assist in the interpretation of programs, philosophy and policies of the district to staff and the community.
- *(21) Work closely with district and school staffs to support school improvement initiatives and processes.

Professional Growth and Improvement

- *(22) Maintain a network of peer contacts through professional organizations.
- *(23) Keep informed and disseminate information about current research, trends and best practices in areas of responsibility.
- *(24) Maintain expertise in assigned areas to fulfill project goals and objectives.
- *(25) Attend training sessions, conferences and workshops as assigned or appropriate to keep abreast of current practices, programs and legal issues.

Systemic Functions

- *(26) Review relevant items for Board agendas.
- *(27) Represent the district in a positive and professional manner.
- *(28) Assist in developing the department budget and monitor its implementation as required.
- *(29) Supervise assigned personnel, conduct annual performance appraisals and make recommendations for appropriate employment actions.
- *(30) Prepare or assist in the preparation of all required reports and maintain all appropriate records.
- *(31) Develop annual goals and objectives consistent with and in support of district goals and priorities.

Leadership and Strategic Orientation

- *(32) Provide leadership and direction for assigned areas of responsibility.
- *(33) Provide support and guidance in the development of annual goals and objectives.
- *(34) Assist in implementing the district's goals and strategic commitment.
- *(35) Exercise proactive leadership in promoting the vision and mission of the district.
- *(36) Set high standards and expectations and promote professional growth for self and others.
- *(37) Utilize appropriate strategies and problem-solving tools to make decisions regarding planning, utilization of funds, delivery of services and evaluation of services provided.
- *(38) Demonstrate initiative in identifying potential problems or opportunities for improvement and take appropriate action.

*(39) Use appropriate styles and methods to motivate, gain commitment and facilitate task accomplishment.
