6. – Superintendent’s Report on Excellence

Tonight, Dr. Flesher began her report by noting that today was the beginning of the second week of school on our main campus and our first day of Preschool at the Discovery Center. She shared that it has been wonderful to see our students returning across the district with so much enthusiasm. Students and staff at the high school and middle school are adjusting well to a small schedule change, and the elementary and middle school teams worked alongside Transportation last week to ensure efficient dismissal, loading, and on-time arrival at home.

Next, Dr. Flesher shared upcoming Homecoming information. Orono will be celebrating the week of September 23-27 with a Friday football game vs. Mound Westonka. She thanked Mr. Joe Huber and the DECA student leaders for once again managing the Homecoming t-shirt design and sales. Proceeds go to our vibrant DECA club to help cover fees and transportation costs.

Dr. Flesher continued with updates from around campus. Orono High School is hosting Back to School night tonight. This is an opportunity for parents to connect with teachers and understand the curriculum planned for the school year. Last week, Orono High School held an Activities Fair during lunches so that students could learn more and sign up to explore clubs and activities. She stated her pleasure in the high level of student participation in sports and clubs and how that is key to our goals of *belonging* and *connectedness*. Cast and Crew have been named for the fall musical, “**Anastasia**.” Tickets will go on sale later this fall with performances beginning November 15. The Orono Middle School fall drama production will be “**The Alibis**” through a cooperative arrangement with 4 Community Theatre. This is a classic “whodunnit” that promises a lot of laughs during performances October 10-13.

Dr. Flesher updated the Board on the construction on campus. The Middle School is in its final stages of construction, with a goal to minimize impact to student programming. She thanked our students and staff for their flexibility, as needed. Along with a thank you to Jim Westrum, Chad Eischens and Nick Taintor for managing this important project.

Dr. Flesher continued with a Spartans Sports Update. The Football team is now 2-0 with wins over Zimmerman and Big Lake. The Spartans return to Pesonen Stadium this Friday against the SMB Wolfpack. This is an important night with the annual Tackle Cancer and Youth Night events. Girls Swim & Dive won their opening conference dual against St. Louis Park on September 5th and are currently ranked #2 in the state in Class A. In Cross Country, the boys team is currently ranked #4 in the state in Class 2A. The girls team is currently ranked #7 in Class 2A. Congrats to Owen Chapman who has taken 1st place individually in all 3 races for the boys so far this season. Dr Flesher congratulated Abby Perrin as well, who recently earned her first **Volleyball** win as varsity head coach against Zimmerman. The team also went 3-1 this past weekend in the Mound Westonka Tournament. Girls Soccer is undefeated on the season, with a 4-0-1 overall record. The girls are currently ranked #9 in the state in Class 2A. And Girls Tennis has won 4 straight matches and are 4-1 overall on the season.


No other New Business was brought forward.
