**SEC. 725. WEWEN KENA.**

Ren popun kena ren ei kisin itenapen:

- (1) Ewe kapas katonong' me pwan katonongen' mi pachenong fitin classes kena me pwan unusen fitinong non foforon sukun kena.
- (2) Ewe kapas ese wor imwen semirit me atekis kena' --
  - (A) wewen pwe aramas kena ir ese kan wor ew mi forino, iteiten, me pwan eochunon fansoun nepwin nenien nonom (me non ewe awewen seni section 103(a)(1)); me pwan
  - (B) mi pachenong —
    - (i) semirit me pwan atekis kena ir ra kan imweimw fengen fiti pwan ekkoch aramas kena pokiten ren nusunon imwer, weiresin moni, ika ew popun mi wewefengen; ra kan nonom non motels, hotels, trailer parks, ika nenien camping pokiten ren an ese wor eochun siwinin anenien kena; ra kan nonom non atepwanepwanen ika asiwininon nenien tumun kena; ra kan koturuno non pioin kena;
    - (ii) semirit me pwan atekis kena ir a wor ew ar aewin nenien nonom nepwin ina a kan ew nenien meinisin ika neni ese suuk ngeni aramas ese foforita ren ika eaea iteiten pwe ew nenien aworen mour ren aramas kena (me non ewe awewen seni section 103(a)(2)(C));
    - (iii) semirit me atekis ir ra kan nonom non chitosa, parks kena, nenien aramas meinisin kena, imw kena mi poutuno, imweimw ese awukukieoch, bus ika train station kena ika neni kena mi usun chok; me pwan
    - (iv) semirit kena ra mokufetan (usun chok kapas kena ra aweweno non section 1309 seni ewe Elementary and Secondary Education Act of 1965) ir ra naf pwe ir ese wor imwer ren ekkewe popun ren ei kisin itenap pokiten ekkewe semirit ra kan nonom non sakkun kena ra kapas usun non clauses (i) through (iii).
