BUSINESS DEPARTMENT (Middle School)

Reason: The course is currently offered at the high school as a .5 elective in the business department. CFM is a required course for students who are pursuing a pathway towards a CTE endorsed diploma. Having students take the course prior to high school offers a larger population of students the opportunity to receive the endorsement.

CAREER AND TECHNICAL EDUCATION DEPARTMENT

ADDITION: Cosmetology (Full Year)

Prerequisite: None

Reason: Data from student surveys, ES BOCES enrollment and local employment outlooks have been analyzed to determine this program to be beneficial for our students to have offered. The program will allow students to receive a NYS recognized license upon completion of the course.

ENL DEPARTMENT

ADDITION: Unified Science (Full Year)

Prerequisite: None

Reason: We would like to bring back this course to assist in satisfying the physical science credit for our ELLs, especially our SIFE students.

MATHEMATICS DEPARTMENT

ADDITION: Discovering Geometry (Full Year)

Prerequisite: Final average below 70 in Algebra 1 with Lab and teacher recommendation and Director approved.

Reason: Many of our most struggling students receive little exposure to Geometry in HS. This course would provide them the opportunity to learn this valuable content.

SCIENCE DEPARTMENT (Grade 8)

ADDITION: Understanding Disasters (Full Year-Alternating Day)

Prerequisite: None

Reason: Student Success Indicators: An interest in both natural and unnatural disasters.

In this course students will study and analyze both natural and man-made disasters that occur throughout our planet. Causes, environmental effects, clean-ups, possible prevention methods, ways to prepare, and any myths surrounding disasters will be discussed. Disasters include, but are not limited to, earthquakes, tornados, tsunamis, oil spills, global warming, and nuclear meltdowns.
