# **MUSIC DEPARTMENT**

ADDITION: Songwriting & Digital Music (Half Year)

Prerequisite: None

Reason: The introduction of the bridge course – Songwriting and Digital Music – also takes the Music Theory Curriculum into the 21<sup>st</sup> Century & presents the material in a fresh and relevant manner appealing to students (particularly to non-ensemble students). After the conclusion of this course, which we propose to be a half-credit (every other day or half year). Students would be well-positioned to continue into Music Theory.

# **READING DEPARTMENT**

ADDITION: SAT Prep: Critical Reading Skills (Half Year)

Prerequisite: Open to students in grades 11, 12

Reason: Students often struggle with standardized testing. This course will provide them with test taking strategies when working for the Reading portion of the SAT exam. Critical reading skills will enable them to determine how to approach the questions that are asked on the exam.
