

Budget Overview for the 2024-25 School Year




This chart shows the total general purpose revenue Learning Choice Academy-East County expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Learning Choice Academy-East County is \$6,735,852, of which \$5,793,870 is Local Control Funding Formula (LCFF), \$630,452 is other state funds, \$114,526 is local funds, and \$197,004 is federal funds. Of the \$5,793,870 in LCFF Funds, \$832,645 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



In 2024-25, Learning Choice Academy-East County is projecting it will receive \$832,645 based on the enrollment of foster youth, English learner, and low-income students. ACTION 1.1 STAFF TO SUPPORT SCHOOL'S PROGRAM: 100% of TLC Teachers and staff have the correct credentials for the positions they are currently working in.

ACTION 1.2 PROFESSIONAL DEVELOPMENT: TLC staff spent many hours on Professional Development this year. In our Second year of MTSS teachers and staff clocked many hours of PD and earned a Certificate for MTSS. TLC was given a grant to have the opportunity to strengthen how we teach students and make gains in the classroom and on tests. Social and Emotional wellness is still a big part of our school along with the use of the SEL and Restorative Justice Programs along with counselors and SEL clubs, students have the support needed. Aperture had 339 total test scores this year, 29% tested in the strength area, 65% tested in the Typical area, and 6% tested in the need area. With the help of the wellness counselor, we were able to focus on these students and make sure Mental Health services were given. SPED staff did many trainings put on by our SELPA. SPED staff also trained Gen. Ed. Staff on accommodations, and modifications in the classrooms. Continued training on NEWA. Staff went to many of the charter conferences, APlus, CCSA, CSDC, MTSS, and All Titles (Title IX).

ACTION 1.3 COURSE ACCESS: COLLEGE & CAREER PREPAREDNESS: Avid continued into its second year. There were no AP courses offered this year. Also, a parent center website where students and parents can go and get resources needed for college. Naviance is still being utilized for students to be able to plan their college and career.

ACTION 1.4 CORE CURRICULUM TO BE PURCHASED: All Curriculum was purchased and distributed at the beginning of the year and throughout the year as needed.

ACTION 2.1 MULTIPLE TYPES OF ASSESSMENTS: This goal was carried out 100% using NWEA, piloting Exact Path, iReady math, end units and chapter tests to name a few.

ACTION 2.2 STAFFING, SERVICES & PROGRAM TO SERVICE EL STUDENTS: since we had a new EL coordinator, she spent most of her time learning who to administer ELPAC and leading the DELAC meetings. She was not able to train staff in the SDAIE, GLAD programs, and the write program was not offered this year by the county.

ACTION 2.3 STAFFING, SERVICES & PROGRAM TO SERVICE SWD STUDENTS: TLC SPED director will continue to improve all services for SWD and continue to have a high-quality program for SWD. TLC staff will continue to work on goals and support students' math and ELA. More IA's were hired to help support some 1:1 in the classrooms. Hired more Ed Specialist due to more Students with special needs. ACTION 2.4 MTSS: STAFFING, SUPPLEMENTAL CURRICULUM, & PROGRAMS TO PROVIDE ACADEMIC INTERVENTION & SUPPORTS: TLC supported teachers every 6 weeks during PLC meetings. During this time teachers would train and look at data to drive what was being taught in the classrooms. MTSS process was used to target students who were in the Tier II and III.

ACTION 2.5 MTSS: STAFFING, SUPPLEMENTAL CURRICULUM, & PROGRAMS THAT PROVIDE SOCIAL-EMOTIONAL/BEHAVIORAL SUPPORT/INTERVENTION: full time counselor for SEL support as well as a Psychologist. Continue to use the DESSA rating to target students who are in the warning zones.

ACTION 2.6 TECHNOLOGY: 1:1 with computers/iPads for the whole school.

ACTION 2.7 STAFFING, PROGRAMS, STRATEGIES & ACTIVITIES TO PROMOTE A POSITIVE SCHOOL CLIMATE, STUDENT ENGAGEMENT & ENSURE A SAFE SCHOOL ENVIRONMENT: Staff helped start clubs at each of the school to promote community. Added a ride share for students who are homeless or far below poverty.

General Information

The Learning Choice Academy-East County (TLC-EC) is an independent study, an academic program serving grades TK-12. Every TLC student enjoys the benefits of a personalized learning plan, personalized attention from teachers, individualized college and career planning, and a flexible schedule that meets their academic and personal needs. Our teachers are highly committed to partnering with parents to provide every student with a personalized and rigorous academic experience.

TLC serves a unique population that has not been successful in the traditional public school system. The focus of TLC is to improve student learning, offer a safe learning environment, and prepare students for college and careers through a flexible learning environment.

Currently, TLC serves approximately 436 students in grades TK-12; of which 70% are White, 64% Hispanic, 10% African-American, 3% Filipino, 1% Asian, 5% American Indian, 0% Pacific Islander, 2.21% two or more races; 23% Students with Disabilities (SWD); 7% English Learners, 0% Foster Youth, 57% Socio-economically Disadvantaged and 14% Homeless Youth.

TLC has 59% of the unduplicated FRPM/EL eligible count. TLC will continue to employ a full-time Psychologist, full-time wellness Counselor, and Instructional Assistants to help in the classrooms and hire more if needed. Will employ Highly Qualified teachers in the areas of Math, Science, and English to help support students after school and on non-classroom days. Will pay for public transportation for students who have trouble getting to school, having students on campus helps with retention and promotes graduation. On-line tutoring 24 hours through paper, any student can access this at their convenience.
