School Responsibilities

Each October, Boaz Intermediate School plans a parent event that extends from early afternoon to later in the evening for parents to schedule parent-teacher conferences at their convenience.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

Each year, Boaz Intermediate School sends home a questionnaire through the PTO for parents to indicate ways in which they would like to volunteer.
