### **Celebrations: Strong Start from Day One**

- 100% coverage of all routes with extra drivers, monitors
- Brand new fleet of buses with top of the line equipment for safety and comfort, including AC
- Zum App Usage: 5,781 (approx. 66%) of transportation families are using the App
  - 2,938 parents have not yet downloaded the App KCPS and Zum are reaching out directly to encourage App usage, where applicable
- Strong collaborative partnership between KCPS & Zum committed to delivering excellent service for students, families, and schools



### Challenges

- **New registrations -** Over 2,000 new students registered for transportation after the start of school and have been added to routes
- **Route Compression** Adjusting routes to alleviate compression in tier 2 and tier 3 routes to improve on time performance for delayed routes
- **Conflicting Trip** Prioritizing home to school routes, and limiting trips (athletics and field trips) that conflict with prime time routes



### **Actions Underway for Continuous Improvement**

- **Daily Route Monitoring and Driver Feedback**: Analyzing live data and feedback to continuously improve efficiency, safety, on time performance
- **Daily Report -** Summary report of buses that are 15+ minutes late presented daily to leadership
- **Route Compression:** Analyzing live data for each tier/route to eliminate compression in Tier 2 and Tier 3 routes
- **Expanding Fleet- Additional Buses:** Zum is sending additional buses to help eliminate compression in Tier 2 and Tier 3 routes
- **Coordination with the KCPS Transportation Team**: Zūm & KCPS transportation team are collaborating closely to ensure timely processing of student and route updates based on priority. This includes updating student assignments, transportation addresses, and stops, as well as identifying programs that require scheduling.



### **Commitment to Service Excellence**

- Continuing to monitor ridership data and removing stops without ridership
- Addressing highest needs routes to get everything on time
- Understanding data to ensure all students are routed accurately
- Goal of achieving:
  - 98% on time performance
  - 4.9 (of 5-Star) parent rating


