



Student Application for Two Roads (Arvada) Parking Lot Access

I agree to the terms and responsibilities stated below and on page two (2) of this document in connection with obtaining authorization to use the parking lot.

I understand that the parking lot is the property of Two Roads and under school ownership and control. I agree that the vehicle driven will not be used to transport or store illegal items on the property. I agree that I will not use the parking lot to violate any federal, state, or local law or any school or district rules.

A search of a student's possessions and/or vehicle is authorized if school officials have reasonable grounds for suspecting it would uncover evidence that said student violated the law or Conduct Code. Therefore, I will cooperate with school officials and/or school security personnel and consent to any search my vehicle and its contents when it is parked on school property or at school sponsored activities or events.

I understand school officials and/or school safety/security personnel will seize any item that violates the law or school rules or provides evidence of a violation of the law or school rules. District codes may require that confiscated items be referred to law enforcement.

I understand that violations of these rules and/or the site based rules on page 2 of this document can lead to revocation of my parking privileges, fines, school discipline (including suspension), and/or referral to Jeffco Schools and/or law enforcement officers.

Rules and Expectations

1. All student vehicles parked in the lot must be registered with the school and **the student parking permit must be displayed** in a location clearly visible from the outside of the vehicle.
2. **Speed limit on school grounds is 5 MPH.** The vehicle must be operated in a safe and legal manner at all times.
3. Students should park in the spaces delegated to students along the south end. There is NO ASSIGNED or RESERVED parking. All spaces are first-come, first-serve.
4. Students are not permitted to loiter in the parking lot or in vehicles before, during, or after school hours, including the lunch period.
5. Parking in fire lanes, no parking zones, and/or restricted areas is prohibited.
6. Violations of rules and expectations (including Jeffco Conduct Code) may lead to parking privileges being revoked or towing as well as law enforcement involvement and school discipline.
7. The parking permit is the property of Two Roads. It must be surrendered upon request by a school official. The permit is only valid for the current school year for the vehicles described in the parking application and will be surrendered at the end of the school year.
8. A parking permit will not be issued if there are outstanding fees and fines with the school financial office. A signature is required from the Financial Secretary to verify this.

**Parking permits will not be issued unless all of these items are available when this form is
submitted.**
