### Review 2024-2025 Meeting Dates

#### DEIC Training

Mrs. Gauthier shared the DEIC Training information with the committee. She
reviewed the roles, terms to serve, and responsibilities each person has as a
member of the committee. She also discussed the ratio of teachers,
administrators, community members, business owners and parent volunteers that
make up the committee.

#### 2024-2025 August Staff Development Review

Mrs. Gauthier introduced Staci Gary and Roxanne Ferguson to discuss the training provided to staff in August. Mrs. Gary reviewed the training the district staff participated in such as compliance training, grade level and department planning, and safety and security. Mrs. Ferguson discussed the preparation and planning for the Pre-K-5 campuses prior to school starting. The middle school campuses reviewed the programs provided by the district for classroom use.

#### Review of 2023 STAAR Scores

 Mrs Gauthier begins with informing the board that accountability on STAAR scores has not been released yet due to a lawsuit. Roxanne Ferguson states that we are focusing on writing k-8 by implementing a program called Empowering writers. She discussed the new science TEKS. Staci Gary stated that we are required to provide accelerated instruction across district to students that fail any subject of their STAAR.

#### Gifted and Talented program Update

- Mrs. Gauthier shared her screen with a slide show of the Gifted and Talented Program Guide along with the Gifted and talented website that has been revamped. Mrs. Gauthier explained the changes in the program. Any student may be referred. She then went over the handbook, which was brought up to a vote.

- Board vote: Unanimous

#### Federal Program Update

Mrs. Gary shared the federal funding that the district received for Title 1 and Title
 3. All four campuses PK-2 and 3-5 qualify as Title 1 and receive money for teacher

and paraprofessional salaries. It also includes funding for parent involvement opportunities. Title 3 monies will fall under the ESL.
