Indicator 8- Parent Survey

Each year, the North Dakota Department of Public Instruction (NDDPI) asks a group of parents, whose children receive special education services, to complete a survey. This survey helps measure how well schools are involving parents to improve services and outcomes for children with disabilities.

The survey includes 10 questions and is sent to a mix of parents with children from preschool through high school. The results are adjusted based on the size of each special education unit so the overall results fairly represent parents across the state.

Parents' responses are scored on a percentage scale. A district's Parent Involvement score is calculated based on how many parents gave a high rating (75% or higher) on the survey questions.

• 6/11/24: 126 completed surveys or 6% of overall child count
