We encourage guests and members of the campus community to become involved and take responsibility for their own safety and the safety of others. As crime can happen anywhere, we encourage those within the campus community to not be complacent with their safety. The information in this annual report is provided as part of Great Oaks Career Campuses commitment to campus safety and meets the compliance standards set forth in the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act of 1998 commonly referred to as the "Clery Act". The Clery Act as amended by the "Violence Against Women Reauthorization Act of 2015", referred as VAWA, require Title IV participating institutions publish an annual report containing safety and security related policy statements and crime statistics. This Report in combination with Great Oaks Career Campuses policies and procedures is intended to ensure that all elements of state and federal law are adhered to and carried out with fidelity. This includes compliance with Title IX's equal protection clauses.

This report is distributed to current students enrolled in post-secondary programs at Great Oaks, as well as to employees no later than October 1<sup>st</sup>, Great Oaks also informs prospective post-secondary students and employees about the availability of the report. #### **DISTRICT SECURITY PLAN**

#### **Reporting Crime and Requesting Security Assistance**

#### In the event of any emergency, call 9-1-1 immediately for assistance

Great Oaks strives to provide safe and secure campuses for all students and staff members, as well as visitors. The term "campus" as used in the Plan includes all buildings on the Scarlet Oaks Campus, public property within or immediately adjacent to and accessible from the campus, and the buildings or property located off campus but that are owned or controlled by the Great Oaks Centers governing board.

Students and staff members who witness any suspicious campus activity are strongly encouraged to report the activity immediately to a designated Campus Security Authority (CSA). The purpose of the Clery Act, a crime is considered reported when it is brought to the attention of a CSA. Further, when a CSA has a reasonable basis for believing that the information related to a crime is true (not a rumor or hearsay), the CSA has an obligation to report that crime to local law enforcement and the Adult Education Director.

The CSA at Great Oaks Career Campuses include the Coordinator of Health and Safety as well as the School Resource Officer (SRO). The SRO is a law enforcement officer employed by the Sharonville Police Department who provides security related services in accordance with 814 a Memorandum of Understanding entered between Great Oaks Career Campuses, the Governing Board and Sharonville Police Department. This individual has the authority to make arrests and works cooperatively with other law enforcement personnel to conduct criminal investigations.

The CSA shall notify the Adult Education Director or another member of the Campus Administration Team about alleged Clery crimes that are reported to them in good faith, or alleged Clery Act crimes that they have personally witnessed.

The Campus Administration will then take appropriate action in accordance with Board Policy, administrative guidelines and established protocols based on the nature of the information provided by CSA. When deemed appropriate local law enforcement authorities will also be notified.

#### **Anonymous Reporting:**

You can anonymously report anything that you believe is suspicious or may threaten or endanger your safety, the safety of others, or the school campus. Text or call the Safety Ohio School Tip Line at 844-SaferOH (844-723-3764) to make a report. The Safer Ohio School Tip Line is available 24 hours a day.

#### **Voluntary Confidential Reporting**

Great Oaks Career Campuses accepts confidential reports and will employ every effort to maintain confidentiality. If, however, a member of the Great Oaks staff believes there is an immediate threat to you or others, Great oaks may be compelled to relay confidential information as appropriate to ensure the safety of all individuals involved.

Ohio Revised Code 2921.22 mandates that anyone other than a pastoral or professional counselor who is aware that a felony took place in the State of Ohio is required to report the crime to police. Therefore, any reports that allege someone may have committed a felony crime will be promptly reported to local law enforcement and District Administrators.

Confidential reports made by professional counselors, health care providers, attorneys and clergy should be directed to the Great Oaks Career Campus Adult Education Director, who will be responsible for issuing a timely warning to the campus community and for capturing statistical data when appropriate.

Any Great Oaks employee who receives information involving a potential crime of any type on Campus shall promptly report the information to their immediate supervisor, the campus SRO and/or the Safety Services Department. In the event of an emergency where disclosure of personally identifiable information is necessary to prevent further or future harm to an individual and/or member of the campus community, the relevant information will be disseminated to appropriate parties.

#### **Incident Reports and Investigations of Clery Act Crime**

Once an incident of dating violence, domestic violence, sexual assault, or stalking has been reported, the district will follow procedures set forth in Board Policy 5517. If a violation is substantiated, appropriate measures will be taken, including issuance of appropriate discipline of the perpetrator(s) and accommodations or protective measures for the victim(s).

#### **Campus Security Programs**

Campus Security procedures are reviewed with all students during orientation. Staff members are briefed on campus security procedures when initially hired. Both staff members and students are encouraged to be responsible for their own security of those around them by carefully reading the campus security procedures and reporting any incidents promptly when they occur.

#### **Great Oaks Career Campuses employs the following security measures:**

- 2- NaviGate Security software.

- a. Houses the Great Oaks Campuses crisis plan, safety report, reporting forms and inspections and flip charts.
- 3- Security Monitoring Cameras
- 4- Electronic Locks
- 5- Fencing
- 6- Lighting and additional CPTED concepts
- 7- Access Control Protocols

#### **Secure Access to Campus Facilities**

Great Oaks Career Campuses maintains a secure campus environment. General access for staff, students, venders, and visitors are restricted in accordance with Board Policy. Staff and students must always have their I.D. badges visible while on campus.

Staff may only enter facilities through an entry equipped with door reader and must use their District issued badge to gain entry. No one is allowed to enter by "piggy backing" through/following behind someone once the entry has been opened or using someone else's ID Badge.

Student access is restricted to predesignated entries that are staffed by a District Employee in accordance with our Lobby Track practices.

All campus visitors, contractors and vendors must check in with a designated employee at the main entrance or must receive prior approval by campus or district administrators to use another entrance. Staff and students are prohibited from propping open any doors or windows that are large enough for someone to enter through without prior approval by a campus of district administrator.

All buildings and exit doors will be secured and locked at the end of the business day. Staff, faculty, and contractors that will be present in a building after normal business hours must notify the campus administration or campus custodial staff in advance.

All post-secondary students enrolled at Great Oaks accept the responsibility to comply with these protocols as a condition of enrollment and agree to follow Great Oaks rules and regulations strictly always. Students who fail to meet this obligation and violate Great Oaks rules and regulations will be subject to appropriate disciplinary sanctions, which may include reprimand, disciplinary probation, suspension, temporary or permanent withdrawal from Great Oaks.

Students and visitors will not be authorized to remain in a building or gain access to a building or area after designated business hours unless prior written permission is

obtained from a campus administrator.

#### Safety Alerts/Timely Warning Notices and Public Safey Advisories

#### 1. Safety Alerts/Timely Notices:

The Clery Act requires Great Oaks to notify students and employees whenever a specific crime has occurred on campus and the threat is determined to be serious and ongoing. The Campus Administration makes decisions about when to issue a timely notice for crimes that occur off campus on a case by case basis depending on the following factors: the nature of the crime, the location, the time of the incident, the local police and first responder response, and the guidance that has been provided to Campus Administration by community officials and the potential direct effect on the campus community.

In situations where there may be an immediate threat to the campus community, the Campus Administration will initiate without delay (upon confirmation of a threat and if doing so does not compromise efforts to contain an emergency) security/safety "Alerts," or "Timely Warnings," using the Achademix notice system. Alerts will be created by Campus and District Administration consultation with local law enforcement and first responders, they will be issued via electronic mail to all members of the campus community, and safety alerts may also be posted in buildings when determined necessary.

A safety alert/timely notice will always be issued for incidents of:

- Murder/Non-Negligent Manslaughter
- Aggravated Assault (situations involving assault among know parties such as students which results in aggravated injury will be evaluated on a caseby-case basis to determine if there is an ongoing treat that warrants an alert).
- Robbery involving Force or Violence
- Sexual Assault
- Major Incidents of Arson
- Any Clery Act crime occurring in the Great Oaks vicinity that is determined to pose a threat by the Chief of Police/Designee or Sherriff's Department.

A timely notice will include the following information (unless issuing any of the information would risk compromising law enforcement):

- Date and time or timeframe of the incident
- Brief description of the incident
- Information that will assist or promote safety and potentially help in the prevention of similar crimes.

- Suspect description when deemed appropriate and when there is sufficient detail to relay.
- Other information deemed appropriate by local law enforcement.

#### 2. Public Safety Advisories

When there is no immediate threat to the safety of the campus community, notification of security/safety concerns are warranted (i.e., patterns of theft), and a "Advisory" may be issued. The primary responder and reports made for the purpose of issuing an "advisory, or "Alert" (or Timely Warning), should be made with approval and support of the Campus and District Administrators, Advisories may be issued for criminal and non-criminal events or issues.

#### 3. Emergency Notifications

Emergency notifications may be issued for other types of emergencies that occur on campus and present a danger to staff and students, such as a report of a shooting in progress, a tornado warning, a bomb threat, or a chemical spill. Campus Administration and staff are trained to respond in accordance with the protocols summarized in the Great Oaks Career Campuses Emergency Management Plan.

The Adult Education Director or designated Campus Administration will determine when an emergency notification needs to be issued based on information that is provided by District Administration, a CSA or local law enforcement officials. The notice will be (GREAT OAKS WILL NEED TO DESCRIBE HOW NOTICES ARE DISTRIBUTED. THIS MAY BE THROUGH BUILDING ANNOUNCEMENTS, ALARMS, ONE-CALL ALERTS ON TELEPHONES, TEXTING, ETC).

Great Oaks will issue emergency notifications without undue delay, the Adult Education Director or Campus Administrator who issues the order will provide sufficient information to assist in supporting the safety of the school community, while considering any concerns that may be presented which might compromise efforts to assist a victim, contain the threat, or otherwise respond to the emergency.

#### 4. Accommodations for Students with Disabilities to Access and Receive Notices

Students with disabilities are encouraged to notify Great Oaks if they would like to request reasonable accommodation so that they are able to access and receive notices. Contact Donna Eakins, Director of Student Services.

#### **Crime Log**

The Great Oaks Career Campuses is required to maintain crime log entries summarizing crimes and conduct violations reported to a (CSA) including an SRO, the Coordinator of Health & Safety, Adult Education Director, Campus Administrators. Staff members should report similar events to the Adult Education Director. The Crime Log will be maintained by

the Campus SRO and the Campus Adult Education Supervisor and made available upon request.

#### **Dangerous Weapons**

A student shall not possess, handle, transmit, conceal, or use as a dangerous weapon which is defined as any instrument capable of causing harm to another person. Dangerous weapons include, but are not limited to:

#### **Firearms**

The definition of a firearm shall include any weapon, (including a starter gun) which will or is designed to or may readily be converted to expel a projectile by the action of an explosive; the frame or receiver of any such weapon; any firearm muffler or firearm silencer; or any destructive device which includes any explosive, incendiary, or poison gas including bombs, both homemade and of the fireworks type, missiles, mines, and military ordinance, including bullets and shells.

#### Knife

The definition of a knife includes, but is not limited to, a sharp blade-cutting instrument. VI. Current Campus Crime Statistics

#### Violence Against Women's Act (VAWA)

These are Dating Violence, Domestic Violence, Sexual Assault and Stalking. Sexual Assault, Domestic Violence, Dating Violence and Stalking are considered primary crimes for the purposes of Clery Act reporting and are defined and discussed in this section.

#### **Campus Sex Crime Prevention Act**

The Campus Sex Crime Prevention Act requires sex offenders to provide notice to each institution of higher education at which the person is employed or enrolled.

#### **Sexual Assault/Misconduct**

Great oaks Career Campuses strive to create a community that promotes personal growth and wellbeing. Sex offenses are illegal, unacceptable and will not be tolerated by the district.

Incidents of sexual assault include both forcible and non-forcible offenses. Prohibited offences include crimes involving dating and domestic violence, stalking and sexual assaults. Upon written request Great Oaks Career Campuses will disclose to the alleged victim of a crime of violence or non-forcible sex offense, the report on the results of any disciplinary proceedings conducted by Great Oaks.

Three very important factors that may help prevent you or a friend from becoming a victim of a sexual assault involve.

1) be an active bystander 2) alcohol and 3) notification to others in the event of an incident involving sexual misconduct or assault (including date rape).

All members of the Great Oaks Community are encouraged to take responsibility for preventing and addressing sexual misconduct within our community. To help enhance your safety and the safety of your friends, commit to be an active bystander by taking the following steps:

- 1- Notice the situation...be aware of your surroundings.
- 2- Interpret it as a problem...do you recognize that someone needs help.
- 3- Feel responsible to act...see yourself as being part of the solution to help.
- 4- Know what to do...educate yourself on what to do.
- 5- Intervene safely...act but keep yourself safe.

You can also enhance your safety and the safety of others when you out with friends by:

- 1- Having a plan...formulate a plan regarding personal safety with friends before you go out.
- 2- Go out together...go out as a group and do not allow friends to become separated, especially if they are impaired or unfamiliar with the parties involved.
- 3- Watch out for others...if you are walking at night with friends and notice a person walking by themselves in the same direction, ask them to join you so they do not have to walk alone.
- 4- Diffuse the situation...if you see a friend coming on too strong to someone who may be too impaired to give proper consent; interrupt, distract, or redirect the situation. If you are too embarrassed or shy to speak out, get someone to step in.
- 5- Trust your instincts...if a situation does not seem right to you, trust your instincts, and remove yourself from the situation, or assist a friend who may not recognize the situation.
- 6- Take care of each other

Alcohol can be a factor in that it can contribute to aggression by the perpetrator or diminish cognitive abilities on your part. Date rape drugs can be placed in any drink, not just alcohol. Do not drink a beverage where you do not know the source, who is serving you or are suspicious of the circumstances. If Great Oaks is not made aware of an incident, we cannot take proper steps to help prevent a future incident. Reporting a crime or incident is a separate step from

prosecuting. Any person who believes they have been a victim of any sexual assault or

misconduct or have information regarding a sexual assault are encouraged to report the incident to the district officials or law enforcement officials, or both.

#### Intervention

Great Oaks is committed to providing both a sensitive and effective response to an incident of this nature. Any of the listed resources will help the victim seek any medical, civil and/or counseling services. Victims of a sexual assault are strongly encouraged to seek immediate medical attention so that physical evidence can be preserved, should the victim choose to prosecute. An assault can be reported without initiating an investigation or prosecuting the alleged attacker. While it is the victims' option to (or not to) seek assistance from law enforcement and campus authorities, Great Oaks encourages persons who have been sexually assaulted to report the assault, seek assistance, and pursue criminal and on campus action for not only their protection, but the entire campus community. Victims should report the assault to the CSA.

The district can help per cure transportation to the hospital and/or the local police department and can assist the victim in notifying proper civil authority. Except for Licensed Counseling Services, health and pastoral counselors, all Great Oaks employees are required to contact a CSA. Confidentiality will be maintained to the extent possible, however, cannot be guaranteed.

#### **Harassment Free Environment**

Great Oaks Career Campuses promotes a productive campus environment and will not tolerate conduct by any member of the campus community that harasses another employee or student, disrupts, or interferes with another, or creates an intimidating, offensive or hostile environment. This includes threatening behavior, violent actions, and sexual harassment. Students who feel they are the target of any type of harassment should immediately report the situation to the Campus Administrator. Employees are to contact the Director of Human Resources. Please refer to the Harassment Free Policy in the Student Handbook and/or the Employee Handbook for further information. Students are protected under Title VII of the Civil Rights Act and Title IX of the Education amendments.

#### **Hate Crimes**

Hate crimes are where the victim is intentionally selected based on his or her actual or perceived race, gender, religion, sexual orientation, ethnicity, disability, national origin, or gender identity. Great Oaks must report any of the above listed crimes, as well as vandalism, intimidation, larceny/theft, simple assault, and any other crime involving bodily injury where bias is a motivating factor. If you believe you have experienced, or witnessed, a hate crime you may report it to the Campus Administrator.

#### **Standards of Conduct**

Great Oaks is committed to maintaining a campus free of illegal drugs or the unlawful use of alcohol or illicit drugs. It is the policy of Great Oaks not to permit the possession, consumption, and sale of alcoholic beverages on campus in accordance with the laws of the State of Ohio, the regulations of the Ohio Department of Commerce, Division of Liquor Control (DOLC) and the policies of Great Oaks. Great Oaks has the responsibility of upholding federal, state, and local laws regarding the use of drugs and alcohol. Students who choose to possess or use unlawful drugs or misuse lawful drugs or alcohol subject themselves to both arrest and prosecution, and Great Oaks action.

#### **Campus Policy Regarding Illegal Substances**

Great Oaks forbids the possession, use or sale of any alcoholic beverages and/or illegal drugs on all campus grounds. Students and staff members should report any knowledge of such activities to the Adult Director. Any infraction is the cause of immediate suspension and termination. When appropriate, such infractions will also be reported to the local authorities.

Specific details of this institution's drug policy are outlined in the campus drug free policy statement distributed annually to all staff and students under separate cover.

#### Student & Employee Compliance with Great Oaks Drug and Alcohol Policies

All Great Oaks students and employees are expected to abide by the terms of the school's policies. A student and/or employee found to be in possession or illegally using drugs and/or alcohol may be subject to appropriate sanctions. Such sanctions may include:

- 1- Referral for prosecution,
- Termination of employment, and/or
- 3- Reprimand, probation, suspension, or expulsion.

A disciplinary sanction may include the completion of an appropriate rehabilitation program. Students and employees are guaranteed due process.

#### **Great Oaks Student Sanctions**

In cases of civil or criminal action against a Great Oaks student, Great Oaks does reserve the right, for educational purposes, to review any action taken by authorities. Great Oaks may, at its discretion, introduce further sanctions if the student's conduct has interfered with the Great Oaks exercise of its educational objectives or responsibilities to its members.

The Great Oaks Student Code of Conduct expressly prohibits the manufacture, distribution, sale, offer for sale, or possession of drugs or narcotics. Violation of this standard constitutes an offense, and the student will be subject to maximum sanction of

disciplinary expulsion or any sanction not less than a reprimand. Being under the influence of drugs and/or alcohol does not diminish or excuse the violation of the Student Code of Conduct.

The Student Code of Conduct also prohibits the possession and/or use of marijuana, and the unauthorized use of alcohol. Violation of these standards constitutes an offense, and the student will be subject to a maximum sanction of disciplinary probation or any sanction not less than a reprimand. Being under the influence of drugs and/or alcohol does not diminish or excuse a violation of the Student Code of Conduct.

A student admitted to Great Oaks accepts the responsibility to conform to all Great Oaks rules and regulations. Proven failure to meet this obligation will justify appropriate disciplinary sanctions, including expulsion, suspension, disciplinary probation, or reprimand.

#### Local, State and Federal Laws and Sanctions

Applicable legal sanctions under local, state, or federal law for the unlawful use, possession or distribution of illicit drugs or alcohol are set forth in the referenced laws and are available upon request from an Adult Education Supervisor.

**Local State:** Ohio Revised Code Chapters 2925 – Drug Offenses 3719 – Controlled Substances 4301 – Liquor Control Laws.

**Federal:** Federal (Harrison) Narcotic Act Federal Narcotic Drugs Import and Export Act Federal Food Drug and Cosmetic Act Federal Alcohol Administration.

These sanctions can include probation, fines, driver's license suspension, and/or incarceration. Future revisions, amendments, or additions to these or other applicable codes are incorporated into this policy by this reference.

#### **DRUG PREVENTION PROGRAM**

#### Drugs and Alcohol (Drug-Free School and Community Act of 1989)

Great Oaks is unequivocally opposed to the misuse of lawful drugs and the possession and use of unlawful drugs. Pursuant to the requirements of the Drug-Free School and Community Act Amendments of 1989 (PL 101-226), Great Oaks has adopted and implemented drug and alcohol policies and programs designed to prevent drug and alcohol problems within the campus setting. The policies and programs are designed to identify problems at the earliest stage, motivate the affected individuals to seek help, and to direct the individual toward the best assistance available.
