The Coordinator of State and Federal programs work alongside principals as well as Teacher Instructional Leaders (TILs) and Curriculum and Instruction staff as it relates to professional development and support around parent involvement at the building level and involvement at the district level. The Parent Teacher Organizations (PTOs) operate as a group; One UCity and are now providing parent programming together instead of through each individual school. Parents are also invited to check on their students' academic progress through the Infinite Campus parent portal. In addition to academic progress, parents can also access attendance, disciplinary infractions, and food accounts. The District IT Department assists each building in the technical supports needed for devices for students and teachers as well as parents who seek assistance with devices and hotspots provided to them. The Communications Department maintains our District website and individual school websites as well as provides assistance with memos and information sent to parents. The Data and Analysis Coordinator provides support as it relates to data collection and analysis.

All of our schools are schoolwide Title I. All school PTOs operate as one organization; One UCity. They aim to build awareness, connections, and community among all families and schools in the district while also building U City Pride. The District has hired a Bilingual Parent Liaison to work with all EL parents to get them more involved and active in the schools and their child's education and academic progress. The LEA also provides training and support for teachers through the Teacher Instructional Leaders to improve instructional strategies and support.

#### Describe method(s) for identifying barriers

The SDUC is a CEP district, as well as all of our schools, are designated as schoolwide. As a result, we have a district-wide (K-12) MTSS program for academic AND for social/emotional needs. This system allows our staff to systematically identify needs beyond the scope of academics, engage parents and arrange wraparound services for students and families, which also falls under the tenants of the School and Parent Engagement Policy.

The annual Title I evaluation process will allow us to identify barriers to parent involvement. As it relates to EL students, the LEA uses the ACCESS test to identify students and track participation. The LEA also maintains a partnership with Special School District and assists with identification and services for students with special needs.
