

Why are we here?





A Statewide School Funding Crisis

School districts **across Texas have adopted deficit budgets** because of lack of action at the **state level** to update **outdated funding formulas**. Some districts have **cut student programs and educational staff** to reduce costs.

- Fox 4: <u>Texas school districts making cuts after state fails</u> to pass funding increase
- Houston Public Media: Amid a lack of state funding, challenges lie ahead for Houston-area school districts in multi-million dollar budget deficits
- KERA: North Texas school districts face millions in budget cuts, closures & layoffs to fend off deficits
- **KXAN:** <u>'At what cost?': Many Central Texas districts make</u> <u>cuts as they face million-dollar deficits</u>
- WFAA: North Texas school districts are stretching financially for the 2024-25 school year





Potential Strategies to Balance Budget

Pause staff raises for teachers, staff, and support
 Increase class-size ratios across all levels and caseloads for support staff
 Reevaluate, modify or eliminate ratios for enrollment-based staffing matrix
 Analyze, eliminate low-enrollment programs and classes

- □ Increase fees in non-core programs and activities
- Modify busing qualification criteria





What is a VATRE? AKA: School Funding Referendum



What is a Voter-Approval Tax Rate Election?

A Voter-Approval Tax Rate Election (VATRE) is a special election that gives the community the power to decide whether to approve a new tax rate for their school district.

Why does it matter?

It impacts the funding available for school programs, staff, and student services.



What is Argyle ISD's history of a Voter-Approval Tax Rate Election?


In 2012, Argyle ISD voters approved a then-called **Tax Ratification Election**. At the time, election dates were chosen by school districts.

Since 2019, Argyle ISD has consistently lowered the Maintenance & Operations tax rate.





Why is AISD Holding a School Funding Referendum?




Inflation Since 2019-2020 Increased Student Population Since 2019-2020 Increased Staff Population Since 2019-2020

• No increase to the state's student funding allotment since 2019



The Impact of Inflation

- **Rising Fuel Prices:** Since 2019-2020, fuel costs have surged, significantly increasing transportation expenses for the district.
- Increased Utility Rates: The cost of electricity, water, and gas has risen sharply, putting additional strain on the district's operational budget.
- **Rising Insurance Premiums:** Since 2019-2020, the cost of insuring school properties and liability coverage has escalated.

Understanding School Finance



How are schools funded?


Public schools in the state of Texas are funded from three main sources: **local school district property taxes, state funds**, and **federal funds**.



Local/Other: Property taxes make up 72% of Argyle ISD's operating budget.

State: The state provides 28% of the budget, but this amount is shrinking as property values in the district rise.


Federal: Federal funds cover specific reimbursements and account for just .002% of the budget.





School Taxes by the Glass

Local property taxes fill the glass first, and the state fills in any space that is left.



*This creates a relationship between local and state funds where when local tax collections increase, state funds to a school district decrease.





How are taxes applied to the budget?

School budgets and tax rates are made up of two parts: **Maintenance and Operation (M&O)** and **Interest and Sinking (I&S)**. The money generated from each part can only be used for specific types of expenses.

M&O

• Purpose: Funds the day-to-day operations of the school district.

- Teacher and staff compensation
- Instruction
- Classroom supplies
- Utilities
- Transportation

Similar to things like:

car fuel, routine maintenance, groceries, clothing, cleaning supplies, and utilities like electricity and water



I&S

- Purpose: Pays for the district's debt, including bonds issued for major capital projects, like:
 - New school construction
 - Major renovations/Facility upgrades
 - Furniture, equipment and/or purchase of land

Similar to things like:

a new home, house renovations, kitchen appliances, new mechanical systems or a new car




How is the money spent?

The general fund, derived from the M&O tax rate, covers the district's operating budget, supporting daily operations, and is divided into the following main areas:

Salaries / Benefits

Salaries & Benefits: 81%, is dedicated to salaries & benefits for educators and staff members.

Campuses & Departments: The remaining 19% is allocated to campuses & departments, supporting various operational needs across schools and administrative units within the district.







Budget Breakdown



A breakdown of the district's budget is represented in the graph below. A large portion of each dollar is spent in the classroom on instructional costs.

When looking for cost reductions, it is difficult to make a significant reduction without impacting the classroom.




Underfunded or Unfunded State Mandates

While the state has not updated funding levels since 2019, it has also **required districts to pay for new programs**. This decreases the funding going to teachers or the classroom.

Required Program	District Cost
Security Mandates	483% more than the state allotment
Special Education	151% more than the state allotment

M&O Tax Rate Decreased by \$0.1854.
Resulting Decrease: \$1,090.42 in school taxes for the average homeowner.

Since 2022:

Average Homeowner's Taxes will still be **\$637.55 lower** even with the proposed increase.

What Happens in a VATRE?





VATRE IMPACT

If Approved:

- The M&O tax rate increases to the proposed rate of \$0.7869.
- More funding becomes available for specific district needs.
- AISD will recommend future competitive compensation for teachers and staff.



- The tax rate stays the same.
- The district may need to consider cuts or adjustments to its budget such as:
 - Class Size Increases
 - Program Reductions or Eliminations
 - Staff reductions

*Reduced resources and support could negatively impact student achievement and outcomes





Cost to Taxpayers, If Approved...

Increase in M&O Tax Rate:

• \$0.077 cent increase per \$100 of taxable home value



Monthly Impact on Homeowners:

If approved, the tax rate impact for Argyle ISD taxpayers would be an **increase of \$6.42 per month for every \$100,000 of taxable home value.**

*For homeowners 65 and older whose property taxes are frozen, this increase will not affect their taxes unless they have made significant improvements to their homes.

With the proposed **School Funding Referendum...**

Argyle ISD will retain **\$2,500,000**

to address budget priorities.

Planned Use of VATRE Funds

2024 - 2025

Initial Allocation: \$2,500,000

- Staff Retention Payment: \$890,000
 - One-time supplemental payment for 24-25 school year currently taken out of fund balance.
- 2% Mid-Point Pay Increase: \$885,000
 - Ongoing annual increase in salaries.
- Budget Deficit Offset: \$400,000
 - Reduces the remaining budget shortfall.
- Classroom Ratios & Future Pay Increases: \$325,000
 - Supports maintaining elementary class size ratios (22:1) and future salary

increases.


2025 - 2026

- Ongoing 2% Pay Increase: \$885,000+
 - Recurring salary increase, adjusted for additional staff.
- 2%-4% Recurring Pay Increase
 - As determined by the Board of Trustees.
 - 1% = \$450,000
- Potential Budget Deficit Balance
 - Addresses any remaining shortfall_**IF**_no additional <u>state</u> support.
- Additional Full-Time Teachers: ~\$68,000 per employee
 - Ensures maintaining **elementary class size ratios (22:1)** and any possible campus support positions



What about Recapture?

Proposition A would bring about \$3.8 million in new revenue to Argyle ISD. Argyle ISD would keep about \$2.5M and the remainder would be subject to recapture by the state.
