Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Holly Drive is a single independent K - 8 charter school serving approximately 103 students. We are located in Southeast San Diego, a community comprised primarily of low-income, minority residents. Most students reside in this area. As a result, Holly Drive’s students mirror the community in which we are located. Approximately 51% of our students are African American, 38% are Hispanic, and 12% are Two or More Races. In the 23-24 school year, approximately 90% of the families qualified for free and reduced lunch, 14% are English learners, and 16% are in Special Education.

The school serves a high-risk population. The school’s vision is to remain under 200 students so that it can offer more individualized attention and a safe family atmosphere. The motto is that Holly Drive is a School Without Walls, offering numerous field trips and learning opportunities outside the school. The intent is to give students the opportunity to experience things outside their community, giving them a broader perspective of the world and providing real-world application to all classroom learning. HDLA is small by design. Our goal is to provide individual nurturing and academic support to students who are not able to thrive in traditional school settings.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The pandemic resulted in increased learning losses for Holly Drive's students and as a result, the school was identified for CSI in 22-23 (based on 21-22 data). Holly Drive demonstrated strong growth in 22-23 and as a result, was exited from CSI. More specifically HDLA overall grew 26.3 points in ELA and 33.1 points in math moving from the red to yellow color bands. HDLA also decreased its chronic absence rate by 8.6% overall moving from red to orange. The school's suspension rate increased in 22-23 to 6.3% moving the school from the orange to red color bands.

Preliminary results from 23-24 indicate the school's improvement trend continues. The school's ELA and math i-Ready results for grades 3-8 show ELA improvement in the early/at/above grade levels and decreases in the proportion of students scoring 2 or more years below grade level in ELA and math compared to last year. We expect to see at least modest gains in our 23-24 SBAC performance. We also decreased our school's overall chronic absence rate by 6% points to 32% and decreased our overall suspension rate 2.3% points to 4%. We are thrilled!

While the trends overall are promising we also face some challenges. The chronic absence rate for our African American students increased from 24 to 27% and the suspension rate for our Latino students increased from 4.7% to 7%.

Reflections: Technical Assistance

As part of the CSI planning process HDLA hired an external consultant to help us identify our strengths and challenges, delve into root causes, and identify improvement strategies. We used the same consultant to help us implement our 2 year CSI improvement plan. While we are no longer in CSI, we will be implementing the second year of our CSI plan in 24-25.

Holly Drive Leadership Academy (HDLA) is an independent charter school and single-school LEA. HDLA was identified for CSI in 22-23 based on 21-22 dashboard results. It has since been exited from CSI but is still in the process of fully implementing its CSI Improvement plan.

Support for Identified Schools

Holly Drive Leadership Academy (HDLA) is a small school with a director and 7 teachers. In order to create its CSI improvement plan, HDLA hired a school improvement consultant. The consultant applied for and received CSI funding and developed the school's needs assessment. All staff reviewed HDLA's CA dashboard metrics for the last four years as well as i-Ready and CAASPP proficiency level data. They identified HDLA's strengths, challenges, and trends. Based on the analysis, the staff prioritized working on increasing the school's math performance and reducing chronic absences. The school engaged in a root cause analysis with key stakeholders delving into the underlying causes of its math and attendance challenges (emphasizing those it could control). As a result, the school implemented the highly rated (based on Ed Reports) i-Ready Classroom Mathematics curriculum in 23-24 and participated in 4 focused i-Ready professional development sessions.

Holly Drive will be implementing a new CSI ELA program for 24 - 25 and staff will be supported with continued math professional development as well as training on its new ELA program.

Monitoring and Evaluating Effectiveness

HDLA is evaluating the effectiveness of its CSI plan at two levels. First, we are confirming the strategies we included in our plan are being implemented and then soliciting staff feedback on their effectiveness. For example, in the case of the curriculum and training, we are using staff survey feedback to evaluate the effectiveness of the training and the degree to which teachers have changed their practice. We will also look at overall performance improvement based on the CA dashboard metrics, CAASPP proficiency level changes, and fall to EOY growth in i-Ready.

Principals, Teachers, Staff, Parents, and Students	Holly Drive engaged its educational partners in the development of the LCAP via its annual parent, teachers/staff and student surveys. In these surveys we get feedback on what our stakeholders like best about the school as well as what they would like to see improved. We followed up the survey with an LCAP planning meeting to allow discussion around suggested improvements and get a better sense of community priorities. In 23-24, HDLA had a student attend our LCAP planning meeting.

The school's decision to focus on improving math and reducing chronic absences in 23-24 directly resulted from teacher feedback. Similarly, its plan to purchase new ELA curriculum and related professional development for 24-25 also came directly as a response to teacher needs. Parents voiced support for the school's small class sizes, safe environment, teacher support, after school program, education field trips, and family fun events. These are all part of Holly Drive's core educational program and are included and funded in the 2024 LCAP. Some parents would like to have a more orderly drop off and pick up routine and the school is reviewing this process.

- **5. Total Planned Percentage of Improved Services (%)**
 - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.

- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**

- This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).

- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**
