The district used general and/or other funds to purchase 1:1 devices. The district will use the remaining balance to purchase interactive smart boards to be installed in classrooms throughout the schools in the district. These smart boards will be utilized by teachers fto enhence student learning and student engagement when teachers are providing whole and small group instruction to students. In the original application the district planned to purchase interactive smart boards for specific classrooms. Now that the district was able to purchase the 1:1 devices through other funds, we would like to enhance the interactive smart boards in other instructional spaces. Our current software products will continue to function with the new devices and our online resources will be enhanced as a result of such. Each classroom has sufficient eletric outlets to support powering the interactive smart boards. Each network closet is currently climate controlled.

Our goal for Amendment 2 is to re allocate all the remaining \$783,331.96 funds, in Tablet Computers, Laptop computers, and Chrome Licenses, to Interactive Whiteboards. Our original SSIP had a calculation for the items Tablet computers. Our original SSIP had Table computes, 855 units at \$425.00, totaled as \$363,596.00. The actual cost should have been \$363,375.00. The error was intentional as the original reviewers instructed us to offset the remaining balance of the SSIP that was not allocated. When calculating our budget there where challenges in arriving at zero, we adjusted quantities and unit costs to allocate our total SSIP allotment.

Amendment 2, Classroom Technology, question 12, has and additional line is added for tablet computers to account for the \$221.00 difference between the allocated \$363,596.00 and the actual total of \$363,375.00.

Amendment 2, Classroom Technology, question 12, laptop computers have a balance remaining of \$396,159.96. We originally budget for a total of 3,252 units, we claimed 1,859 units, leaving remaining 1,393 units. I adjusted the per unit cost to \$284.39 to arrive as close to the original approved \$396,159.96. There is a balance of \$4.69 not allocated which I reconcile out in the following line, subtracting the -\$4.69.

Interactive whiteboards are quoted at a cost, \$4,499, I adjusted that amount to \$4,501.83, at a quantity of 174, arriving at \$783,318.42. I cannot adjust the quoted cost, or quantity, any more to fully reallocate the remaining \$783,331.96, leaving a balance of \$13.54. I added another line for Interactive Whiteboards to reconcile the balance of \$13.54.
