TWO-YEAR PROGRAM - 450-hour program IN PARTNERSHIP WITH PARADISE VALLEY COMMUNITY COLLEGE

- Learn substantive and procedural areas of law, including legal ethics, civil procedure, legal research, and legal writing.
- Acquire legal skill sets and prepare for industry certification and employment in a multitude of legal settings.
- Develop critical thinking, problem-solving, and communication skills essential for success in any legal career.

PROGRAM REQUIREMENTS*

- Current **Sophomore** students may apply (early graduates may not apply)
- Grade 10: Placement into college-level Reading and Writing by using **ONE** of the college placement tests below:
 - Accuplacer Next Gen Reading: 249 or higher
 - Write Placer: 5 or higher
 - OR
 - EdReady Critical Reading: 90 or higher
 - EdReady English Placement: 80 or higher
- Copy of unofficial transcript
- Proof of residency in West-MEC district boundaries
- Copy of birth certificate and immunizations/State Exemption Form due at the time of enrollment
- Transportation is not provided by West-MEC. Families are responsible for providing transportation to and from West-MEC.
- Student State-issued ID, driver's license, or driver's permit due at the time of college enrollment
- Parent Proof of Citizenship & 1 year of Arizona residency due at enrollment (non-resident is responsible for the difference between in-state and out-of-state tuition)

*Program requirements are subject to change per industry age restrictions, certification requirements, and administrative discretion.

COST REQUIREMENTS

Upon acceptance into the program:

- \$150.00 non-refundable registration fee includes enrollment processing
- It is recommended that students have access to a personal computer and reliable internet outside of class to complete assignments and projects.
- Dress code is reviewed to meet professional industry standards. Dress code is business casual for this program. Dress code requirements are addressed before the start of classes.
- College textbook- approximately **\$0** (using free online resources)

Tuition

- If a student graduates or obtains a GED prior to program completion the student will be responsible for tuition.
- Empowerment Scholarship Account (ESA) recipients are responsible for tuition. West-MEC is an approved vendor.
- Student Tax Credit (STO)/Private School Scholarship recipients are responsible for tuition.
- Students who reside outside of West-MEC boundaries are responsible for tuition.

INDUSTRY CREDENTIALS

If eligible, students will have the opportunity to test for the following credentials.

FEES PREPAID BY WEST-MEC; It is the responsibility of the student to maintain copies of all earned credentials.

- This industry credential is required for employment in the field a majority of the time
 - None at this time.

Proof of Citizenship or Legal Permanent Residency may be required for credential testing. Students with a documented disability may request credential testing accommodations through the individual testing entity.

ENROLLMENT INFORMATION

- Acceptance into West-MEC programs may be competitive.
- Students may only be enrolled in **one** West-MEC Central Program at a time.
- The order for filling seats by grade level is as follows:
 - Current Sophomores
- Applications are ranked in part by attendance, GPA, discipline, and career choice (ECAP)
- Program hours are not excused for participation in extracurricular activities, athletics, vacation, or employment.
- West-MEC's priority application submission date is in February. Contact your counselor for your application deadline.
- West-MEC students served under an IEP/504 will need to self-advocate for reasonable accommodations through the Paradise Valley Community College Disability Resource Office. Approved accommodations may differ from those provided in the high school. The Americans with Disabilities Act requires higher education institutions to provide reasonable accommodations to those with documented disabilities, provided an undue hardship is not created. STUDENT SUCCESS INDICATORS

- History of good attendance and discipline (Strict post-secondary attendance guidelines will be followed.), and on track for graduation

- Critical thinker, analytical, and strong time management skills
- Confident writing skills
- Ability to get along with other students and cooperate with the instructor
- Ability to work accurately/follow procedures to an industry-standard
- Strong technical reading and study skills; the textbook for this course is written at the college reading level

*An 70% grade or better is required for each Paralegal course in order to obtain college credit and be eligible to progress to the next level course.

**A 60% grade or better is required to obtain high school credit.

CREDITS ISSUED BY WEST-MEC

- High School - 3 elective credits (0.75 credits per semester)
- This program satisfies AZ University's admissions requirements. (AZ Board of Regents CTE/Fine Arts credit)
- A student who withdraws during the West-MEC program may receive concurrent enrollment college credit based on the number of completed courses. (see post-secondary opportunities)
