Our district Federal Programs Advisory Committee which is made up of representatives from each school's CIP team, meets two times per year to review a needs assessment, Title I plan and set asides for the upcoming year. An Annual Federal Programs Informational Meeting for all parents will be held in each school prior to September 30. The district Parent Involvement Specialist will provide a PowerPoint Presentation which explains the District Set Asides, with emphasis on the 1% set aside for Parent Involvement. The presentation will also cover the Title 1 requirements, Parents' Right-to-Know, and opportunities for parents to be involved in their child's education and as a volunteer at the school. A handout will be provided for all attendees with a written summary of the information covered in the meeting. A detachable section is provided for their signature as well as their comments, complaints, and/or suggestions. The detachable forms will be collected and used as additional parent input and will be considered in a future CIP committee meeting.

Blountsville Elementary schedules events throughout the school year at various times of the day. Our Meet Your Teacher Day is hosted in afternoon and early evening hours to accommodate parents. Parents can schedule an appointment to meet with their child's teacher any time during the school year. We have an open house in the fall known as our Tiger Showcase for parents to visit our school and meet with teachers. We schedule PTO meetings in the evenings and have fun programs presented by students to showcase their many talents. We have a Night of the Arts for grades 4th-6th to show off their art projects and to perform in the talent show for family and our community.

Blountsville Elementary parents serve as part of the Continuous Improvement Plan (CIP) committee. At least two local parents serve on the LEA's Parent Involvement Program's Parent Advisory Council. All parents are given the opportunity to make suggestions and offer ideas through a survey in the spring of each school year.

Results from the annual Parent Survey are summarized and all comments are listed and provided to the principal for use in planning the Continuous Improvement Plan.

This year, we will be using our Parent Involvement allocation to purchase 2-way communication folders. They provide a structured way to share important information, such as announcements, schedules, and events, helping keep parents informed about what's happening at school. These folders also allow for feedback from both teachers and parents. Parents can express concerns or ask questions, while teachers can provide comments on student progress and behavior. By facilitating communication, we encourage parent involvement in their child's education, fostering a partnership between home and school. We will also be purchasing materials and supplies to support parent communication, including copy paper for flyers, etc.

All classroom teachers send a newsletter home to parents which includes information about upcoming events, curriculum to be covered the next week, any assessments that are scheduled and what those tests involve, and other information that parents/guardians need to know in order to help their children succeed. The Blountsville Elementary website includes announcements, current and upcoming events, lunch and breakfast menus, and information on how to contact the school. Parent-teacher (PTO) meetings, Meet Your Teacher, and other parent-centered events are scheduled to keep parents informed. All parental involvement information packets and notices are translated for all parents. The Parental Involvement coordinator and system-wide translator are housed in the same office. The LEA testing coordinator provides assessment information in the translated form and the EL Consulting teacher provides parents with information in the language they request.

The Blountsville Elementary School-Parent Compact (available in both English and Spanish) was customized to our school and approved by the Continuous Improvement Plan Committee on which parents serve. During the Meet Your

Teacher event, held before the opening of school in the fall, teachers meet with parents and have them and their children sign the compacts. If they are unable to attend the meeting, a copy is sent home with the child on the first day of the new school year. If the copy is not returned in a reasonable time, a telephone contact is made and the parent/guardian is encouraged to sign the compact and return it. A copy of BES's School-Parent Compact is on the school website. The compact consists of three sections: (1) School Responsibilities to parents and students (including important events and the School Mission Statement) (2) Parent Responsibilities with regard to their child's education, and (3) Student Responsibilities to help insure their academic success. The compact also includes an area for documentation of parent/ teacher conferences held throughout the year. The School/Parent Compact is stored in the student's home room and made available to all teachers serving the student. An annual review of the compact allows us to keep it updated. Parents and teachers are encouraged to use the compact as a communication tool during Parent/Teacher conferences and other meetings involving both the parent and the teacher.

The Continuous Improvement Plan (CIP) is developed by the CIP committee, which is made up of administrators, teachers, and parents. Blountsville Elementary begins work on our CIP during May and the final plan is submitted for the school board's approval in October. Several work sessions are conducted and input from the entire faculty and other stakeholders is gathered. Parent representatives serve on the CIP committee and all parents are also given an opportunity for input each year through the system-wide Parent Survey. Other opportunities exist to express dissatisfaction with the CIP at the school and county-wide level. Events such as Meet Your Teacher Day, Awards Day, PTO meetings, Field Day bring parents in the school on a regular basis, giving them an opportunity for making practical suggestions for program improvement. Since we are a small community, many of our teachers participate in community activities, bringing them in contact with our stakeholders. There are many opportunities for informal feedback about school programs. The Blountsville Elementary CIP Committee will review, evaluate, and revise its Continuous Improvement Plan annually. Parents can review the CIP on the school website. The 1% set-asides summary sheet provided for each school's annual meeting has a section for comments, suggestions, and complaints. If parents/ stakeholders find something not satisfactory, they have the right to submit their concerns in writing to the school. The CIP Committee will review the concerns of the parents before submitting the final CIP to the central office.

At Blountsville Elementary School, teachers have email accounts that can be used by parents to access information and communicate with the teacher. We also use the Schoology Learning Management System. Students and parents can access learning assignments in the Schoology Learning Management System. Teachers, parents, and students can communicate about assignments and grades through the Schoology platform. The program provides parents and students with a means of accessing school information from home or any location via the internet. Our system is also utilizing PowerSchool Parent Portal, an information service that can be used as a communication tool to help increase parental involvement and promote student achievement. Parents are given access codes to their child's PowerSchool data. Parents can view their child's grades in the Schoology platform. This information may include report card grades, daily grades, test grades, current class averages, attendance, and discipline data. The school website contains lots of information and is updated frequently. Also, there is a Parent Involvement link on the district website. We have literacy meetings throughout the school year to inform parents about the Alabama Literacy Act and how it affects their child. We also provide opportunities for them to engage with teachers and learn strategies to make literacy activities at home fun and worthwhile.

Parents are invited to come to school for formal conferences regarding their children. The Blountsville Elementary School website has links to email each teacher. All teachers utilize their email to communicate with parents as needed. All teachers regularly send home newsletters to keep parents informed about school activities and current standards being taught. The Schoology Learning Management System offers parents and teachers another format to access information and communicate about school events, academics, and grades.

To ensure effective involvement of parents and to support a partnership among the school, parents, and the community to improve student academic achievement, our school:

We have PTO meetings with a theme focus on numeracy and literacy topics. Grade levels Kindergarten, 1st, 2nd, and 3rd grade provide entertaining programs to delight the community. Our teachers and staff present meaningful information to parents to foster literacy skills for our students. Our teachers and reading coach put together packets of information to give parents with ideas and tools they can use to help their child at home. We also have many community resources and helpful links for parents on our website. In addition to the general education staff of each school, we have a system wide ESL consulting teacher, a Spanish translator, and a McKinney-Vento coordinator. These individuals work collaboratively to meet the training needs of the parents of our homeless, migrant, and non-native English speaking students.

To ensure effective involvement of parents and to support a partnership among the school, parents, and the community to improve student academic achievement, our school:

Blountsville Elementary School provides, to the extent practical, all information that parents need to know in the language spoken in the home. Our EL aide is fluent in Spanish and assists with translating during meetings and translating documents. As needed we request the services of the ESL/ Migrant Liaison. The district's ESL/ Migrant Home Liaison provides translations of documents going home to parents of English Language Learners. Informational flyers are also translated as well as handbooks, policies, parent involvement plans, newsletters, and parent surveys. Registration, medical, disciplinary, health, and sports related forms are also translated. When feasible, software services such as Transact are used. To the extent practicable, information posted to the parent involvement link on the district website is available in both English and Spanish. Recognizing the need to assist in bridging the gap of the linguistic diversity of students at school, communication handouts, signs, and directions are often translated into native languages spoken at the school. The ESL/ Migrant Liaison is also available to attend IEP meetings, disciplinary hearings, and parent/teacher conferences to serve as a translator for non-English speaking parents.

An annual Parent Survey is conducted during the spring quarter of each year. Information is sent home with each student notifying parents about the importance of the survey and how to find the survey on the Internet. The survey is located on the Blountsville Elementary website and are also available on the Blount County School System website. Parents without Internet access are invited to the school to use our computer lab to take the survey. Information gained through an analysis of the completed surveys assist in planning and integrating parent involvement programs and activities which address parents' needs so that they are effective partners in the academic success of their child.

Translators and sign-language interpreters are on staff with the Blount County Board of Education to ensure that all parents are able to understand the information being presented. All schools and facilities are handicap accessible including our local school. Reports and information, including student progress notes and report cards, are available in Spanish, or other languages (as needed). Special accommodations are continuously made to communicate with parents by phone and home visits as needed. We have an EL aide in our building daily that is fluent in Spanish and is available to assist with translating. A Migrant Liaison is on staff at the Blount County Professional Development Center, offering a wide variety of supports which also include the following:- Translating and support at events including I.E.P. meetings and school functions- Translation of written materials including parent compacts, student handbook, newsletters, progress notes, report cards, etc.- Home visits to encourage school attendance and respond to needs beyond the school day (tutoring needs, clothing, hygiene, food, medical, immunizations, dental, vision, financial aide, school supplies, etc.). Our Migrant Liaison and our EL teacher work together to inform migrant families of support services offered (posters, flyers, school notifications, dedicated direct phone line, booths at local events to inform parents of EL and migrant students of support services, etc.).
