Dear Member of the Junior Class:

Parking availability for the 2024-2025 school year* is a privilege earned by eligible students. The requirements for eligibility are as follows: a student must have a valid New York State driver's license (learner's permits will not be accepted), an automobile, good academic standing, and have earned fifty (50) Safe Driving Points.

If you are interested in a parking space for the 2024-2025 school year, the enclosed application must be completed and signed by you and your parent/guardian.

Parking Applications must be submitted to the Main Office along with the following:

- clear copy of your driver's license
- clear copy of the vehicle's registration (for each vehicle listed)
- signed copy of the North Salem High School Parking Rules and Regulations
- signed copy of the Parental Permission form.

Parking spaces, once assigned, are not guaranteed for the year. Poor attendance, excessive unexcused lates, and other disciplinary related events can result in the loss of an assigned parking space. **Underclassmen are not-permitted to leave campus without permission at any time during the school day.**

Completed applications will be accepted by mail or in person.

Safe Driving Points Requirements For Eligibility:

-If you have taken Drivers Education (25pts) and Officer Armstrong's class (25pts), you are eligible for to apply for a parking spot.

-If you have taken Drivers Education (25pts) but have **NOT** taken Officer Armstrong's class (25pts), you are eligible to apply for a parking spot. You will have 30 days from the start of school to complete Officer Armstrong's class (schedule TBA).

-If you have **NOT** taken Drivers Education, but have taken Officer Armstrong's class (25pts), you will need to submit 3 Personal Reflections (<https://www.northsalemschools.org/domain/75>) to be eligible to apply for a parking spot.

- If you have **NOT** taken Drivers Education, Officer Armstrong's class or submitted reflections, you will need to submit 3 Personal Reflections (<https://www.northsalemschools.org/domain/75>) and you will have 30 days from the start of school to complete Officer Armstrong's class (schedule TBA).

NORTH SALEM HIGH SCHOOL PARKING RULES AND REGULATIONS 2024 – 2025

The North Salem High School administration reserves the right to deny, grant, or withdraw driving and parking privileges to any student at any time during the school year.

GENERAL INFORMATION:

1. Parking a vehicle on school property is a privilege, not a right. Please review all parking regulations with your parents. Students who park on campus must be “in good standing” with the school.
2. Excessive tardiness and illegal absences will result in a loss of parking privileges.
 - greater than 10 unexcused lates to school = 7 day parking suspension
 - greater than 20 unexcused lates to school = 14 day parking suspension
 - greater than 30 unexcused lates to school = loss of parking privilege
3. Parking privileges can be rescinded due to inappropriate behavior or poor academic performance.

VEHICLE REGISTRATION INFORMATION AND CONSEQUENCES FOR NON-COMPLIANCE:

1. Students who operate a motor vehicle on campus should fully understand their duties and responsibilities. Students who violate parking regulations are subject to any or all of the following consequences:
 - Revocation of parking privilege
 - Ticketing
 - Disciplinary action
2. Only one space will be issued per student. Students may register up to two of their family vehicles.
3. Students with proper registration must park their motor vehicles in their **assigned parking space**, front-end first.
4. Vehicles must be parked in **assigned spaces**. Students may **not** park in un-numbered faculty spaces, visitor spaces, or other undesignated areas. Vehicles parked in the wrong space, or unauthorized areas, will be ticketed and parking privileges will be subject to revocation.
5. Inform the main office immediately of any changes in vehicle or license plate. A copy of the vehicle registration will be required.
6. **Parking spaces are non-transferable. Students may not sell, or give their assigned space to another student.**

PARKING LOT SAFETY

1. All students must abide by all New York Traffic Laws regarding seat belt usage and automobile operations when on campus, arriving or departing campus. Failure to abide could result in disciplinary action and revocation of parking privileges.
2. The school district is not responsible for damages to, or theft from, vehicles. Students are cautioned NOT to leave valuables in their vehicles. Parked vehicles should be left with windows closed and doors locked.
3. Student vehicles are subject to search if there is reasonable suspicion to believe that drugs, alcohol, stolen property, or other contraband is present in the vehicle.

LEAVING CAMPUS

1. **Underclassmen are not-permitted to leave campus without permission at any time during the school day. Driving such students off school property will result in disciplinary action and possible revocation of parking privileges.**
2. Any student who checks out of school early must follow early dismissal sign-out procedures in the main office.

We have read and fully understand the Parking Rules and Regulations for North Salem High School. We understand that a violation of any of the above regulations or school policies may result in temporary or permanent revocation of the parking privilege.
