### Introduction and General Information

### Introduction to the School Board Transportation Report

New fiscal realities have not only impacted families but also have had an adverse effect on city, municipal, county, state, and federal budgets. Driving much of the economic volatility on a local level has been the depressed real estate market, high unemployment, and poor investment returns. All of this has a direct impact on the annual school district budget and the decisions we must make in order to maintain balanced finances. This has required our District to carefully analyze spending priorities amid limited alternatives. That same process takes place every day within the households that make up our student and parent base, as well as among all other taxpayers and residents living in our District.

When an option exists to cut District spending in a way that involves creating efficiencies rather than eliminating programs, it makes sense to thoroughly explore that choice. Such an option emerged from the transportation subcommittee of the Community Budget Task Force.

The transportation subcommittee's proposal will make major strides in increasing the efficiency of the student transportation system. A transformation of this magnitude must include four main elements, with the first being Board direction to move to the planning stage. The second requires transportation department planning to map out how the new routes, bus stops, and bell schedule changes would work together. The third includes a comprehensive communication program to inform parents of the proposed changes while collecting parental feedback. The final step involves School Board members review of feedback while considering the benefits of the proposal compared to complications it may cause, culminating in the vote on a motion to adopt the plan for 2011-12.

The primary purpose of this report was to document the process the committee conducted over the last five months and to provide Board members with the data necessary for them to make an informed decision regarding the 2011-12 transportation changes. An important part of the process was gathering community feedback and supplying appropriate responses to it. A complete list of community outreach initiatives is included in this report detailing the methods and timing of parent and District staff communications. In cases where parents requested changes to their specific bus stop locations, they have been advised that an individual review process will be established and communicated following a Board vote to adopt the 2011-12 plan.

The Board must now consider the overall impact of the proposal on District finances as well as its impact on students and families. The components of stop locations and bell schedule changes all work together to allow for a reduction in the number of buses contracted for use. Distinct components of this plan must be considered as a whole, as each element is contingent on another's implementation. No one aspect of the proposal can be excluded if the total \$1 million budget savings are to be realized.

Through this process the District partnered with our community to create a plan that protects classroom instruction, lessens the burden on District taxpayers, reduces the budget gap, and fosters a focus on our mission of education.

### FACTS ABOUT WEST CHESTER AREA SCHOOL DISTRICT STUDENT TRANSPORTATION

### 1. Is the West Chester Area School District required to provide transportation?

No, regular education student transportation is not mandated by the Pennsylvania Department of Education. Bus service, funded in part by state subsidies, is extended as a courtesy by the district to all public and non-public school students residing in the West Chester Area School District. The state does mandate that once bus service is provided for any segment of the district's student population, service must also be provided for students in all programs, whether public or private/parochial.

### 2. How many students does the District transport?

The district transports approximately 11,746 public school students, 4,312 non-public students and 383 charter school students for a total of approximately 16,441 students. The WCASD transportation operation is the fifth-largest in the State of Pennsylvania.

### 3. How many schools does the District transport students to and from?

The District provides transportation to 16 public schools, 128 non-public schools, 6 charter schools and 38 special-education programs.

### 4. How many Out of District schools does the District transport students to and from?

The District transports students to 86 non-public schools and 29 special-education programs outside of the WCASD boundaries.

### 5. Over how many miles does the District transport annually?

The district transports public school students over an area covering 75 square miles. For non-public students, the District transports students over a 750 square mile area each school day. For the 2008-09 school year, district busses traveled 3,678,000 miles.

### 6. How does the District determine who is eligible for transportation service?

The West Chester Area School District will provide any resident student transportation to and from kindergarten, elementary school, or secondary school located within the district boundaries or outside the district boundaries at a distance not exceeding ten miles by the nearest public highway. According to PA School Code the District may ask a child, regardless of age, to walk up to a mile and a half to a school provided the route is not deemed hazardous. The District has established Board policy based on this parameter. For more information please see the WCASD student transportation policy ED.

### 7. <u>Is the West Chester Area School District required to provide transportation to students with special needs?</u>

Yes, the District is required to provide transportation to students identified with special needs. This requirement is not governed by the 10 mile radius limitation. The District is required to transport the student to the educational program regardless of distance from District boundaries.

### 8. <u>Is the West Chester Area School District required to provide transportation to students enrolled in charter schools?</u>

Yes, the District is required to provide transportation to any resident student enrolled in a charter school within a 10 mile radius of the district boundaries. For more information please see attached link\* to the PA Public School Code

### 9. Is the West Chester Area School District required to provide mid-day kindergarten transportation?

No, mid-day kindergarten transportation is not mandated by the Pennsylvania Department of Education, but rather a courtesy extended by the district to all Public and Non-public school students residing in the West Chester Area School District.

### 10. <u>Is the West Chester Area School District required to provide transportation to and from day care providers?</u>

No, the District offers this service as a courtesy to all public and non-public students residing in the West Chester Area School District. In addition, the District offers the flexibility to allow for students to be dropped off/picked up at multiple locations.

### 11. Does a school district have to provide transportation to a nonpublic school?

When a school district provides transportation for its public students, it must provide transportation services to nonpublic student of the same grade level that it is providing for its own pupils. The nonpublic school must be nonprofit and located within ten miles of the district's boundary.

### 12. Does the District own the bus fleet or is this a contracted service?

The District contracts this service from two different providers. The District utilizes Krapf's for the majority of the public and non-public transportation and On The Go Kids for the majority of the special education transportation needs.

### 13. How many buses did the WCASD utilize in the 2009-10 school year?

The district utilized 69 buses to transport our public school students, 82 buses to transport our non-public students, 59 buses to transport our special education students, and 19 for mixed public and non-public students for a total of 229 buses.

### 14. <u>Does the District use routing software to establish transportation routes?</u>

Yes, the District's Transportation Department relies on both internal and external personal experience, a detailed knowledge of the geographic area as well as routing software to create transportation routes that are weighted heavily on student safety.

### 15. Does the state dictate how long a child may be required to ride on a bus?

PA School Code does not dictate how long a child may be required to ride on a bus. The District has established a Board Policy which states that a student's ride time will be limited as much as possible to no more than 1 hour within District boundaries. For more information please see the WCASD student transportation policy ED on the District's Website.

### 16. <u>Does the state have any regulations regarding the combining of public and non-public students on</u> one bus?

No, the state does not have any regulations regarding the combining both public and non-public students on one bus.

### 17. Does the state have any regulations regarding the combining of students of various grade levels on one bus?

No, the state does not have any regulations regarding combining students of various grade levels on one bus.

### 18. What was the cost associated with student transportation for 2009-10?

In 2009-10, the district spent \$12,870,072, which included \$4,670,437 to transport our public school students, \$4,953,487 for our non-public students, and \$3,097,300 for our special education students.

### 19. What is the projected cost of student transportation for 2010-11?

The projected cost of student transportation for 2010-11, which will not involve changing bell schedules or bus stop locations for all schools, is \$13,154,554.

### 20. What is the annual cost of a bus?

The average annual cost of a bus is \$54,533. The actual cost varies depending upon many factors which include the miles drives, fuel consumption, capacity utilization and specialized equipment needs. On average the cost of a bus used to transport public school students is \$43,970, non-public students \$70,210 and special education students is \$55,735.

### 21. May a fee be charged to pupils who ride a school bus?

No fees may be charged of students riding busses to public or private schools. Section 1361 of the School Code states that when a district provides transportation to its students, it is to be free and paid for out of district funds.

### 22. <u>Has the District considered additional means in the area of transportation in order to save</u> money?

Yes, even though the District is not required to do so by state code, a national competitive Request For Proposal (RFP) process was just completed in order to determine the most responsible vendors to provide the lowest cost transportation services. Other typical means to control costs include participating in a consortium to purchase bus fuel and reviewing the status of RFP contracts on a regular basis.

### 23. Does the District receive state reimbursement for student transportation?

Yes, the District does receive reimbursement for transportation services based on a very complex state formula. The formula takes into consideration many factors such as:

- Actual Costs
- Miles drives
- Capacity Utilization
- Bus size and age
- Hazardous Routes
- Charter School transportation costs
- District wealth

For the 2008-09 school year the District received reimbursement from the State of Pennsylvania in the amount of \$4,828,866, which equates to a reimbursement rate of 38.5%. The State defines the capacity of a regular size bus as 72 students. The subsidy formula provides the most subsidies to districts that have a ridership of 72 students on every regular size bus. This is also referred to as

100% capacity utilization. School districts are therefore financially penalized for not filling buses to their 72 student capacity, or less than 100% capacity utilization.

### 24. What is the District's current capacity utilization of the buses?

The average capacity utilization for the public elementary schools is 69%. Because of the size of middle and high school students, the transportation office defines 100% capacity utilization for secondary buses as 48 students instead of the higher number used by the State. Even with this lower number, the average capacity utilization of the middle school buses is only 82% and for the high schools it is even less at 69%. For the nonpublic schools the average capacity utilization is the lowest at 47%.

### 25. Why aren't we loading our buses to capacity?

The following factors impact our ability to fill our buses to their capacity: the number of square miles we must travel to a school; road congestion and increased traffic signals; number of stops we are making for student pick-ups and drop-offs; nonpublic students whose homes are scattered throughout the district and who are attending public schools within a ten mile radius of any district boundary; and, limits we have imposed on our maximum student ride times.

### FACTS ABOUT THE PROPOSED 2011-12 TRANSPORTATION PLAN

### 26. When would proposed consolidation of bus stops and change in public school bell schedules take effect?

New public bell schedules, non-public route consolidation, and consolidated bus stops for public and non-public students would go into effect at the start of the 2011-12 school year.

### 27. Why is the school district consolidating bus stops and changing public school bell schedules?

In the current economic environment budget cuts have become an annual necessity, and it is challenging to identify cuts that do not directly affect the classroom and our students' education. Adjustments to bus and bell activity will save \$1 million per year, and impact children in a way that does not affect the educational program. For example, public school elementary bell schedules will only change by ten minutes for six schools and by just twenty minutes from the current system for the four others. In addition, Fugett Middle School will experience a bell schedule change to mirror that of East High School, again not affecting the educational program. Bus stop consolidation will require a number of students to walk a bit further to and from their bus stops following all state regulations regarding student safety while walking.

### 28. What if the District didn't change the transportation plan?

If the District does not take the transportation savings, including those gained from bell schedule changes, the 2011-12 budget gap would require cuts in things that would affect the education program. The District would have to find \$800,000 in cost reductions to replace transportation, keeping in mind that transportation does not have as direct an impact as other cost reduction initiatives on how our educational program is delivered.

Last year the District found \$7.7 million in budget reductions without affecting the integrity of the classroom. The only cuts left to consider for 2011-12 other than transportation will result in a reduction of programs and services. A few examples of potential program cuts include: the

reduction of five elementary library aides to save \$165,000; reducing five elementary school psychologists to cut \$425,000; reducing two high school counselors to save \$134,000; reducing five elementary school gifted teachers allowing for a cut of approximately \$335,000. All of these examples would affect a large number of children in a very direct way, whereas transportation changes represent only a schedule modification.

### 29. If these changes are helpful, why weren't they implemented for the 2010-11 School Year? Why is the District waiting until 2011-12?

The School Board seriously considered implementing the proposed changes and gaining the budget reductions for 2010-11. It was determined that the scope of the changes, the time required to gather feedback from public and non-public parents, and the importance of communicating the changes multiple times in a wide variety of ways made rushing these plans into place undesirable, creating too much disruption and inconvenience for families to be justified.

### 30. <u>Is it possible to change public school bell schedules to get savings without consolidating many of the bus stops?</u>

No, the financial benefits of changing the public school bell schedules come directly from consolidating bus stops in order to move students to and from school in a way that allows for the use of fewer busses. In order to achieve the desired savings, one element of the plan cannot be enacted without the other.

### 31. Where did the idea come from to consolidate bus stops and change public school bell schedule plans?

The proposal was developed by the Transportation Committee of the Community Budget Task Force. Its members reviewed a great deal of data and proposed the plan in their final report to the Superintendent and School Board. The Transportation Committee was a group of 24 volunteers which included 13 public school parents, and two non-public parents, as well as contractors and other taxpayers and residents.

### 32. What other resources did the Transportation Committee of the Community Budget Task Force rely on in creating the recommendation to consolidate bus stops and change public school bell schedules?

A national transportation consulting group, Transportation Advisory Services (TAS), reviewed the data and process used by the Community Task Force's Transportation Committee as well as the recommendations in the final report. The data included the history of services in the District, district maps, state subsidy data, department information, School Board polices, state laws and regulations, federal safety mandates, the District's transportation contract, school locations and bell times; current bus capacity information, hazardous route information, and other general route data. Such authoritative oversight helped insure that all appropriate cost savings measures were considered and the recommendations, if accepted, could be implemented in a safe and manageable way.

33. Would the proposed changes to public school bell schedules and the bus stop consolidation plans be permanent, or will things revert to our current system once the district's budget crisis eases?

Because significant savings of more than \$1 million can be achieved without directly affecting educational programming, and with a minimal impact on student schedules, this more efficient transportation plan will remain in place into the future to the benefit of district taxpayers as a recurring, sustainable, cost-cutting measure.

### 34. <u>Is the Board aware of the emails sent or comment cards filled out by parents with information about their concerns?</u>

The committee provided copies of all emails and comment cards sent by parents to the Board members via their secure website so that parents' personal information was not visible to general public.

35. When will the final decision be made regarding the implementation of a new transportation plan? The WCASD School Board is expected to take a vote at its monthly public meeting to be held on Monday, November 22nd, 2010, at 7:30PM.

### Communications Task Force for 2011-12 Transportation Savings Meeting August 25, 2010

<u>Attendees:</u> Patricia Barr, Marc Bertrando, Chris Gray, Ann Helion, Christa Heyward, Barb Martz, Jim McAssey, Laurie Micken, Sara Missett, Suzanne Moore, Michele Porco, Dennis Reiter, Jim Scanlon, John Scully, Barb Shea, Matt Washlick, Le Roy Whitehead, Joanne Yarnall

- Dr. Moore handed out an agenda for the meeting and a folder containing information on the District's website about the implementation of the 2011-12 changes. She asked that the committee members review the Q&A document and at the next meeting the committee members should recommend additional questions that could be added. She also reported on the parent communications that the district completed during the summer and the system created for the nonpublic parents. Joanne Yarnall handed out the communication printed on the back of every public and nonpublic bus schedule sent out in August.
- The committee discussed the parent input meeting dates scheduled for September 15<sup>th</sup>, 21<sup>st</sup> and 22<sup>nd</sup>. Everyone agreed that the September 15<sup>th</sup> date had too many conflicts with other meetings in the District and would need to be rescheduled, and the meeting locations should be moved to District school buildings and not be held at Spellman Administration Center. At least one meeting should be held at Fugett Middle School.
- The Committee discussed the meeting formats and everyone agreed that the first meeting should be a "meet- and greet". The Committee would do a brief presentation on the changes to the large audience, and following this there would be separate meeting rooms for each finding. Parents and Staff would go to the respective room to discuss their concerns with a committee person who was responsible for that particular topic. The major topics were identified as (1) nonpublic bus consolidation, (2) Fugett bell schedule change, (3) elementary bell schedule change, (4) and bus top consolidation. (Based on feedback from Marc Bertrando, Joanne Yarnall, and Suzanne Moore, the committee decided to remove the High School Parking Permit Finding from consideration.)
- To maximize efficiency, subcommittees were formed (see table below) so that members could concentrate on a specific topic which minimized the need for each committee member to be an expert on every issue. It was also discussed that other people would be needed to help out the subcommittees during the parent meet-and- greet because there weren't enough committee members to help all the parents that may attend. For example, Sara Missett stated that she would recruit elementary principals to help with the elementary bell schedule change subcommittee, and Marc Bertrando stated that he would ask principals and assistant principals to help with the Fugett bell schedule change subcommittee.

- The committee members discussed the need for using a formal collection system to document parent concerns during the meet-and-greet. Asking parents to fill a card at each "topic room" was suggested.
  - The committee members debated how to handle communications for the bus stop consolidation finding since it impacted parents across elementary, secondary public schools and the nonpublic schools. Also, it was unlikely that transportation office would have time to get bus top location reports ready for the September parent meetings since its regular work peaked in August/September. Committee members felt that parents would not have enough information to identify a concern unless they had the new location of their bus stop. It was decided that the committee members would continue to explore solutions to this dilemma. AFTER THE MEETING ADJOURNED, IT WAS SUGGESTED TO PRESENT THE BUS STOP CONSOLIDATION TOPIC AT THE LAST PARENT MEETING INSTEAD OF THE FIRST PARENT MEETING. THE TRANSPORTATION OFFICE MAY BE ABLE TO FINISH THE REPORTS ON THE NEW BUS STOP LOCATIONS BY THAT TIME, THE INFORMATION WOULD BE AVAILABLE FOR PARENTS.
- Next meeting is scheduled for 6:00 PM, September 8<sup>th</sup> at Spellman Building.

### <u>Communications Task Force for 2011-12 Transportation Savings</u> <u>Meeting September 8, 2010</u>

Attendees: Patricia Barr, Marc Bertrando, Chris Gray, Ann Helion, Barb Martz, Sara Missett, Suzanne Moore, Michele Porco, Dennis Reiter, Jim Scanlon, John Scully, Matt Washlick, Le Roy Whitehead, Joanne Yarnall, Maria Pimley Dr. Moore handed out an agenda for the meeting along with the 8/25/10 meeting minutes and revised Committee action steps.

The committee agreed that there will be two parent meetings held on <u>October 12 at 4:30 PM and October 14 at 7:00 PM</u>.

The Committee agreed that the format should be a "meet- and- greet" for both meetings. The Committee would do a brief presentation on the changes to the large audience, and following this there would be separate meeting rooms for each finding. Parents and Staff would go to the respective room to discuss their concerns with committee members who were responsible for that particular topic as established at the August 25<sup>th</sup> meeting (see meeting minutes).

Since the meeting dates were changed from September to October, the transportation office would have more time to put together the bus stop location information for the bus stop consolidation recommendation. With the information available to them, parents would be more able to express their concerns. This solved the problem discussed at the August 25<sup>th</sup> meeting.

The Committee agreed that their future meeting would be held on <u>September 22 and October 6<sup>th</sup> at 6:00 PM</u>. After the parent meetings, the committee would need to regroup to finish their final recommendations to the Board.

The committee discussed the preparation of the final recommendations to the Board due on November 8<sup>th</sup>. The report would contain parent concerns and a list of solutions that would address parent concerns. The committee discussed the importance of creating solutions that did not lose the integrity of the original recommendations, since all the changes to the bell schedules and bus stop consolidations were intertwined. If one of the recommended changes was revised, it would disrupt the other parts of the plan and little savings would be achieved. When the Board makes its decision on approving the plan they will need to consider whether the committee's solutions were effective in addressing the parent concerns. Except for the nonpublic school transportation changes, the plan will need to be considered in its entirety.

Dr. Pimley advised that the perception of parents is that their input will result in major changes to or elimination of the task force committee's individual recommendations. To deal with this misunderstanding, the committee agreed that all future communications needed to inform the parents of the limitations to the changes.

The committee discussed how they will inform parents of the October meeting dates. The administration will prepare a parent email and phone blast for the public schools and send post cards to the nonpublic schools. The information will include a link to a webpage that will list the "groups" of students who will be impacted by each recommended change. It was also suggested to include a link to the frequently asked questions. Dr. Scanlon stated that he would call all the nonpublic schools that are impacted by the bus and transfer point consolidations.

After the large committee finished its meeting, the subgroups met for the rest of the evening to work on the following:

- identifying specific student who will be impacted by the subgroup's change
- listing parent and staff issues and list responses to the issues using the Q&A as a starting point
- identifying handouts and other information available for parents/staff at the parent feedback meetings

In addition, each subgroup was asked to name a group leader, note taker and writer of the final recommendation to the Board.

### <u>Communications Task Force for 2011-12 Transportation Savings</u> <u>Meeting September 22, 2010</u>

Each sub-committee reported on the progress of their preparation for the parent meetings.

- Bus Stop Consolidation: Dr. Moore provided a handout that listed names of the developments impacted by bus stop
  consolidation. Additional developments needed to be added as well as other areas in the District that are not in a "named"
  development. She also handed out a brochure that the subcommittee developed. It listed the criteria used to establish walking
  routes and bus stop locations.
- 2. <u>Nonpublic Route and Transfer Point Consolidation</u>: Mr. Scully discussed the parent letter his sub-committee developed for the non-public parents. He also stated that Dr. Scanlon called all the nonpublic schools impacted by the nonpublic bus consolidation. The committee is continuing to work on their list of school impacted by the nonpublic recommendation.
- 3. <u>Fugett Middle School Bell Time Change</u>: Dr. Bertrando handed out answers that the sub-committee wrote up for questions parents have about the Fugett bell time change. The questions were based on meetings Mr. Whitehead held with parents to seek input. Dr. Moore will ask Mr. Partridge to use the sub-committee's feedback to update the Q&A on the website. Mr. Whitehead will be meeting with his faculty on October 6<sup>th</sup> to get their feedback and ask a Fugett teacher to participate on the committee.
- 4. <u>Elementary School Bell Time Changes:</u> Dr. Missett reported that the sub-committee is still working on teacher work day times and will get feedback on this issue. She will be meeting with staff to get feedback on October 6<sup>th</sup> and she will be available in the buildings after school if there are additional questions. Meanwhile, she stated that answers to some of the Q&A questions should be revised to reflect up to date information including teacher workday, 30 minute difference in bell times for the elementary schools, and the Y program. Elementary teachers Tyra Quail and Nancy O'Banion joined the sub-committee to offer advice based on their knowledge of school operations.

The committee suggested revisions to the Q&A for questions A3 and D3, and they suggested revisions to the information listed on the Parent Feedback Meeting Dates webpage.

The committee discussed the face to face communications with parents and concluded that much of the discussions may tend to be emotional. It was suggested that the committee members should be mindful to use empathy in their responses to parent concerns. It was suggested that the committee develop responses so that members' communications are consistent with each other.

Leroy will inform the committee of the room numbers assigned for the Meet and Greet sessions with the parents.

Each sub-committee reported on the progress of their preparation for the parent meetings.

- 1. <u>Bus Stop Consolidation</u>: Dr. Moore stated that based on parent feedback the committee will be printing bus stop location information for every student. This information will be sent to each school so that students can take home the bus stop location information to parents.

Based on the original recommendation of the Transportation Committee, as part of the 2009 Community Budget Task Force initiative, the June meeting of the School Board included a directive to the administration to move forward with the composition, communication, and gathering of feedback with regard to 2011-12 transportation plan changes. Nearly \$1 million in budget reductions are to be realized through the implementation of the interconnected elements of the proposed transportation plan.

A combination of information and communication vehicles was used to get the word out to public and non-public families utilizing District transportation services. Vehicles used include the following: a kick-off newspaper article; development and launch of a comprehensive website information resource with a parent-feedback comment component; distribution of multiple waves of parent letters which were mailed as well as taken home by students; Superintendent e-mails to public and non-public families via e-news ListServe distribution list and All-User internal notification; and public meetings designed to provide parents with information and gather feedback.

During the course of September and October, meetings were also held with the leadership of the WCAEA with a focus on elementary school teacher support of the bell schedules and a special focus on Fugett Middle School teachers regarding their bell schedule change.

### District Preparing to Roll Out Schedule Changes

WEST GOSHEN — The West Chester Area School District is gearing up to inform parents and students about bus and bell schedule changes that could save more than \$1 million next year.

The district plans to reduce the number of bus stops district wide from 4,716 to 3,696. This will involve changing the time the school days at some schools start and end and consolidating some of the routes taken by non-public school buses, district officials said.

The school board voted Monday on a timetable the district will follow when informing parents about the plan.

This month, the district will form a Community Transportation Communication Committee, which will make final adjustments to the cuts. The committee, which will be composed of some of the same community members who sat on the district's Community Budget Task Force last year, will then begin to communicate information about the cuts to the public and to district stakeholders.

In September, the district will hold feedback meetings with parents, staff, and teachers about the cuts. Some school district parents have criticized the timing of these meetings; they said that because school starts in September, parents have a lot on their hands and are less likely to attend.

The district plans to send the cuts to the school board for approval in October. This means the cuts would not be implemented until the 2011-12 school year.

During the 2010-11 budget negotiations, which wrapped up in May, some school board members pushed for these transportation cuts to be implemented this year. But other board members said the school district should take its time and properly warn parents of the impending transportation changes.

The version of the transportation cuts the school board discussed earlier this year called for:

Switching Fugett Middle School from an 8:05 a.m. to 2:50 p.m. school day to a 7:30 a.m. to 2:15 p.m. school day.

This would allow East High School and Fugett Middle School, which are on the same property, to have the same bell schedule, which would in turn allow students from both schools to ride the same buses, officials said. The district's other two middle schools would still follow their normal schedules.

Staggering elementary school bus schedules.

All 10 elementary schools now run from 9 a.m. to 3:30 p.m. The new proposal calls for East Bradford, East Goshen, Glen Acres and Exton to run from 8:40 a.m. to 3:10 p.m. and for the other elementary schools to run from 9:10 a.m. to 3:40 p.m. This would allow elementary school buses to run two routes instead of one, officials said.

Having more non-public students transfer from one bus to another during their way to school.

This would reduce the number of non-public buses, officials said.

- Dr. Moore handed out an agenda for the meeting and a folder containing information on the District's website
  about the implementation of the 2011-12 changes. She asked that the committee members review the Q&A
  document and at the next meeting the committee members should recommend additional questions that could be
  added. She also reported on the parent communications that the district completed during the summer and the
  system created for the nonpublic parents. Joanne Yarnall handed out the communication printed on the back of
  every public and nonpublic bus schedule sent out in August.
- The committee discussed the parent input meeting dates scheduled for September 15<sup>th</sup>, 21<sup>st</sup> and 22<sup>nd</sup>. Everyone agreed that the September 15<sup>th</sup> date had too many conflicts with other meetings in the District and would need to be rescheduled, and the meeting locations should be moved to District school buildings and not be held at Spellman Administration Center. At least one meeting should be held at Fugett Middle School.
- The Committee discussed the meeting formats and everyone agreed that the first meeting should be a "meet- and-greet". The Committee would do a brief presentation on the changes to the large audience, and following this there would be separate meeting rooms for each finding. Parents and Staff would go to the respective room to discuss their concerns with a committee person who was responsible for that particular topic. The major topics were identified as (1) nonpublic bus consolidation, (2) Fugett bell schedule change, (3) elementary bell schedule change, (4) and bus top consolidation. (Based on feedback from Marc Bertrando, Joanne Yarnall, and Suzanne Moore, the committee decided to remove the High School Parking Permit Finding from consideration.)
- To maximize efficiency, subcommittees were formed (see table below) so that members could concentrate on a specific topic which minimized the need for each committee member to be an expert on every issue. It was also discussed that other people would be needed to help out the subcommittees during the parent meet-and- greet because there weren't enough committee members to help all the parents that may attend. For example, Sara Missett stated that she would recruit elementary principals to help with the elementary bell schedule change subcommittee, and Marc Bertrando stated that he would ask principals and assistant principals to help with the Fugett bell schedule change subcommittee.

- The committee members discussed the need for using a formal collection system to document parent concerns during the meet-and-greet. Asking parents to fill a card at each "topic room" was suggested.
- The committee members debated how to handle communications for the bus stop consolidation finding since it impacted parents across elementary, secondary public schools and the nonpublic schools. Also, it was unlikely that transportation office would have time to get bus top location reports ready for the September parent meetings since its regular work peaked in August/September. Committee members felt that parents would not have enough information to identify a concern unless they had the new location of their bus stop. It was decided that the committee members would continue to explore solutions to this dilemma. AFTER THE MEETING ADJOURNED, IT WAS SUGGESTED TO PRESENT THE BUS STOP CONSOLIDATION TOPIC AT THE LAST PARENT MEETING INSTEAD OF THE FIRST PARENT MEETING. THE TRANSPORTATION OFFICE MAY BE ABLE TO FINISH THE REPORTS ON THE NEW BUS STOP LOCATIONS BY THAT TIME, THE INFORMATION WOULD BE AVAILABLE FOR PARENTS.

The committee agreed that there will be two parent meetings held on <u>October 12 at 4:30 PM and October 14 at 7:00 PM</u>.

The Committee agreed that the format should be a "meet- and- greet" for both meetings. The Committee would do a brief presentation on the changes to the large audience, and following this there would be separate meeting rooms for each finding. Parents and Staff would go to the respective room to discuss their concerns with committee members who were responsible for that particular topic as established at the August 25<sup>th</sup> meeting (see meeting minutes).

Since the meeting dates were changed from September to October, the transportation office would have more time to put together the bus stop location information for the bus stop consolidation recommendation. With the information available to them, parents would be more able to express their concerns. This solved the problem discussed at the August 25<sup>th</sup> meeting.

The Committee agreed that their future meeting would be held on <u>September 22 and October 6<sup>th</sup> at 6:00 PM</u>. After the parent meetings, the committee would need to regroup to finish their final recommendations to the Board.

The committee discussed the preparation of the final recommendations to the Board due on November 8<sup>th</sup>. The report would contain parent concerns and a list of solutions that would address parent concerns. The committee discussed the importance of creating solutions that did not lose the integrity of the original recommendations, since all the changes to the bell schedules and bus stop consolidations were intertwined. If one of the recommended changes was revised, it would disrupt the other parts of the plan and little savings would be achieved. When the Board makes its decision on approving the plan they will need to consider whether the committee's solutions were effective in addressing the parent concerns. Except for the nonpublic school transportation changes, the plan will need to be considered in its entirety.

Dr. Pimley advised that the perception of parents is that their input will result in major changes to or elimination of the task force committee's individual recommendations. To deal with this misunderstanding, the committee agreed that all future communications needed to inform the parents of the limitations to the changes.

The committee discussed how they will inform parents of the October meeting dates. The administration will prepare a parent email and phone blast for the public schools and send post cards to the nonpublic schools. The information will include a link to a webpage that will list the "groups" of students who will be impacted by each recommended change. It was also suggested to include a link to the frequently asked questions. Dr. Scanlon stated that he would call all the nonpublic schools that are impacted by the bus and transfer point consolidations.

After the large committee finished its meeting, the subgroups met for the rest of the evening to work on the following:

- identifying specific student who will be impacted by the subgroup's change
- listing parent and staff issues and list responses to the issues using the Q&A as a starting point
- identifying handouts and other information available for parents/staff at the parent feedback meetings

In addition, each subgroup was asked to name a group leader, note taker and writer of the final recommendation to the Board.

### To Parents of Non-public School Students Utilizing WCASD-Provided Transportation

The West Chester Area School District is experiencing the same financial challenges other organizations and families have faced due to the severe downturn in the economy. In an effort to help balance the district budget a Community Task Force of citizen volunteers was formed last year to identify District-wide cost reductions. Volunteers were drawn from public and non-public households, as well as from our business community and other residents within the District.

Several proposed initiatives impact transportation services with implementation planned for the 2011-12 school year. These proposals will impact both public and non-public students who use transportation services provided by the WCASD. The most notable proposed changes for our non-public students will entail bus stop consolidations, route consolidations and transfer point changes.

Parents are strongly encouraged to attend one of the informational meetings being offered by the District to better inform the public, and to allow for parent questions and comments. Two meetings will be conducted. These informational sessions take place prior to the plan's scheduled submission to the School Board for its consideration and approval vote. Registration is *not* required to attend a meeting.

Transportation budget savings are based upon enacting *all* elements of the 2011-12 proposals. Each component is contingent on another's implementation, and it is not possible to leave out one part of the proposal while moving forward with another. To do so would result in a failure to achieve the desired budget reductions.

The West Chester Area School District will be conducting two meetings this month to discuss the proposed changes to our transportation schedule, bus stop consolidation and school starting times for the 2011-12 school year. Meetings will be held at Fugett Middle School, 500 Ellis Lane, West Chester at the following times:

The start times were chosen to try to accommodate different schedules. Each meeting will feature breakout rooms staffed with knowledgeable District personnel to address individual questions and comments.

In the current economic environment, budget cuts have become an annual necessity. Our 2011-12 transportation plan is a cost saving measure taken from our Community Budget Task Force Findings and includes adjustments in bus services for public school and non-public school students.

It also includes some modifications to bell schedules for the public schools in the West Chester Area School District. Under the proposal, every elementary school in the district will start either 10 minutes earlier or 20 minutes later, and Fugett Middle School will start 40 minutes earlier. While the plan is not ideal, it will save our taxpayers \$1million per year while leaving the delivery of educational programs unaffected.

# DISTRICT STUDENTS ARE HIGH ACHIEVERS

 Tudents in the West Chester Area School District continue to for third grade students in both math and reading, with 94% proficient or advanced in math and nearly 90% proficient or significantly outperform state averages on the Pennsylvania System of School Assessment (PSSA). All 16 of our schools made Annual Yearly progress under the federal law, No Child Left Behind. West Chester Area School District was one of only two Chester County School Districts to show improved scores advanced in reading. The annual Pennsylvania System of School Assessment (PSSA) testing is administered every spring to measure each student's attainment of academic standards. Reading and math assessments are given to students in grades 3 through 8 and 11; writing assessments are taken by students in grades 5,8 and 11, and science assessments are completed by those in grades 4,8 and 11. According to their scores, individual students are rated Advanced, Proficient, Basic or Below Basic. The Advanced level reflects superior academic performance and an in-depth understanding of the standards. Proficient reflects satisfactory academic performance with a solid understanding of the required skills. Basic levet reflects marginal academic performance; while Below Basic reflects inadequate academic performance

### Rationale:

- Increasing the amount of time between the TIERS will allow the routes to be longer and pick up more students to fill a bus.
- Since the District essential pays for a bus for the day, adding two TIERS at the elementary level will allow a bus to be utilized longer and will save costs by completing more routes with fewer buses.

# Savings:

- The 2011 2012 budget saving will be \$50,000 x 12 buses = \$600,000.
- The total savings above result from the combination of secondary and elementary school bell changes as well as bus consolidation.

# COMMUNITY FEEDBACK

Two parent feedback meetings were held on Tuesday, October 12, 2010 and on Thursday, October 14, 2010. The meetings allowed the administration to address parent concerns regarding the proposed changes in the elementary bell times for the 2011 – 2012 school year. The committee received 13 comment cards and 17 emails from parents and community members. The report also details the proposed bell times and the buildings that will be affected by transportation implementation plan.

### **Committee Findings**:

Listed below are general concerns that have been submitted by parents to the committee. It is important to note that within the responses, some respondents expressed concerns with multiple issues. After the chart is a Q&A that provides clarifying information and responses for each category of parent concerns.

The following chart shows the frequency of which respondents commented on each of the categories.

The WCASD staff was surveyed in late September 2010. The comments from that survey are in the appendix of this report.

# ELEMENTARY BELL CHANGE PROPOSAL QUESTIONS AND ANSWERS

# 1. Will the public school bell schedule changes and bus stop consolidations affect the ride time for public school students?

Yes. Consolidating bus stops may actually shorten the ride time within the district for many students since the busses will be making fewer stops. The district policy with regard to ride time in the district has not changed.

# 2. <u>I'm worried that the elementary schools dismissing later might cause students to miss certain</u> after-school activities, including those not school-related.

The transportation office did a comparison of current drop off times and the new drop off times, and found that the scheduled drop-off times for each route will not differ dramatically from current schedules, however, individual student experiences may be different in some cases.

# 3. <u>Will some elementary school parents likely have to adjust how they handle day care arrangements if the bell schedule changes are made?</u>

Yes, small adjustments may become necessary. Currently elementary parents drop off their students when teachers arrive at 8:15 without having to use YMCA day care. For schools that change to an 8:40 start time, parents will still be allowed to drop off their students at 8:00. Also, since buses will be picking up students earlier in the morning, this may be more convenient for parents who previously could not use the bus service due to the bus schedule's conflict with the parents' work schedules. For schools that change to a 9:10 start time, parents will be able to drop off their students at 8:30 which is a 15 minute difference from the 8:15 time.

For students who are in schools that have an ending bell time of 3:10 instead of 3:30 may have an extra 20 minutes in daycare. For students who are in schools that have an ending bell time of 3:40 instead of 3:30, they may arrive in day care a maximum of 10 minutes later than currently. Please understand that the pick-up and arrival times for any student could change based on many factors other than the bell schedule change.

We recognize that these changes may impact current day care arrangements. We fully expect that the before and after school day care service offered by the YMCA in our buildings will adjust program times accordingly. This service will remain available in each elementary building for the convenience of parents.

# 4. Will the public school bell time changes for the elementary schools impact buses for special education students? Will my child's ride time be impacted?

No, since no special education bus goes to more than one elementary school, there will be no impact to the length of the ride for special education students. On the other hand, special education students attending classes at a particular elementary school will have bus schedules that will accommodate the new bell schedule at that school.

# 5. <u>Some parents have stories about crowded buses. Is the District aware of this, and will bus stop consolidation or the public school bell schedule changes lead to overcrowding?</u>

Yes, such comments have been shared, but in the District's effort to save taxpayers money by utilizing fewer buses, the continued goal is to have as many buses run at full capacity as possible. We must also ensure that the new transportation plan does not violate School Board policy or state and federal laws and regulations relating to school bus operation. This will require strict adherence to policies such as requiring students to take only their assigned bus home, except in cases of home emergencies, school tutoring, or medical service needs. All District buses are equipped with digital cameras. In continuous reviews of onboard recordings we have never found a time when a seat was not available to a student. Any report of a student standing on a moving bus would be a safety violation which we would take very seriously. In no case shall a bus be permitted to operate with a load that is above its rated capacity.

# 6. What are the proposed public elementary school bell schedule changes for the 2011-12 school year be if the new transportation plan is approved by the School Board?

The 2011-12 proposed public elementary school bell schedules are included in the report.

# 7. How will the elementary teacher workday changes impact the District-wide after school teacher meeting times?

There will be a twenty minute difference in the end of the day for teachers at the elementary schools, so there will be a minimal impact to the start times for after school meetings.

# 8. <u>I am currently a teacher for an Extended Day Kindergarten class and am concerned about how the different bell schedules will change the program.</u>

The Extended Day Kindergarten program will continue but the "sister" school partnerships will be changed. The district will ensure public schools that have similar bell times will be paired.

# 9. <u>Can staff request a transfer to a different building based on changes made to building bell schedules?</u>

As part of the staffing process for the 2011-2012 school year, the District will certainly consider any staff member's request to be reassigned to a different building based on building bell schedule

changes which result from the new Transportation plan. In order to receive consideration staff should complete the "Request to Transfer Form" available on the District website at: www.wcasd.net/admin/transfer\_requests.asp

# 10. I'm worried that the elementary schools dismissing later might cause students to miss certain after-school activities, including those not school-related.

The transportation office did a comparison of current drop off times and the new drop off times, and found that the scheduled drop-off times for each route will not differ dramatically from current schedules; however, individual student experiences may be different in some cases.

# 11. Will the public school bell time changes for the elementary schools impact buses for special education students? Will my child's ride time be impacted?

On the other hand, special education students attending classes at a particular elementary school will have bus schedules that will accommodate the new bell schedule at that school.

# 12. Is the West Chester Area School District required to provide mid-day kindergarten transportation?

No, mid-day kindergarten transportation is not mandated by the Pennsylvania Department of Education, but rather a courtesy extended by the district to all Public and Non-public school students residing in the West Chester Area School District.

# 13. <u>Is the West Chester Area School District required to provide transportation to and from day care providers?</u>

No, the District offers this service as a courtesy to all public and non-public students residing in the West Chester Area School District. In addition, the District offers the flexibility to allow for students to be dropped off/picked up at multiple locations

# Secondary Public School Bell Schedule Changes

# SECONDARY BELL SCHEDULE CHANGES

# INTRODUCTION

Based on the community task force's transportation committee mandate to find savings, and after analyzing the background information for the transportation operations, the subcommittee established a goal to eliminate a minimum of 12 buses from the District's transportation operations. The crucial factor in the decision to eliminate buses was that the majority of them were not being filled to capacity. One of the findings of the committee was to change the bell times to gain efficiency in daily routes and use of buses. The staggered start times will allow for bus route consolidation, increased bus capacity utilization and will help reduce the WCASD transportation budget. The secondary bell schedules are changed as follows:

Middle Schools	Student Bell	Teacher Work Day
Current Bell Schedule	8:05 – 2:50	7:30 – 3:00
Bell Schedule Change for Fugett (no change for Stetson and Pierce)	7:30 – 2:15	7:20 – 2:50
High Schools	Student Bell	Teacher Work Day
Current Bell Schedule	7:35 – 2:20	7:20 – 2:50
Bell Schedule Change	7:30 – 2:15	7:20 – 2:50

# Rationale:

- Buses are currently not filled to their capacity. Current capacity utilization of public school buses is 82% for middle school and 69% for high school.
- The combination of Fugett Middle School and East High School buses increases
  efficiency and increases capacity utilization because the schools are on the same
  campus and the students are in the same neighborhoods.

# Savings:

- 2011-2012 budget savings will be \$50,000 x 12 buses = \$600,000
- Total savings above result from the combination of secondary school and elementary school bell schedule changes as well as bus stop consolidations.

# COMMUNITY FEEDBACK

# Introduction:

After the informational sessions concerning the proposed WCASD Transportation Plan conducted at Fugett Middle School on October 12<sup>th</sup> and 14<sup>th</sup>, the administration received twenty-nine feedback forms and seventeen emails.

# **Findings**:

When the community responses were synthesized, there were several categories that emerged, and they appear below. It is important to note that within the responses, some respondents expressed concerns with multiple issues. After the chart is a Q&A that provides clarifying information and responses for each category of parent concerns.

The following chart shows the frequency of which respondents commented on each of the categories.

1. Parents are concerned with their middle school children interacting with high school students at the bus stop and on ride to school.

- a. The drivers serving the East/Fugett complex have experience with both middle school and high school students. Seating arrangements will be structured to allow the younger students seats in the front of the bus and older students in the back. Professional development has already begun and will continue with training seminars in the fall and spring. Monitoring will take place utilizing digital cameras installed on all buses.
- 2. <u>Parents are concerned that their middle school children will be required to awaken too</u> early, which is counter to current adolescent sleep research.
  - a. The transportation committee has considered the school start time changes and how they will affect student achievement. In fact, the committee polled eight local and/or regional school districts that begin their middle school day at 7:35 or earlier. Seven reported that there was no impact on student achievement and one school district reported that their scores actually improved.
  - b. The district is aware of the published research that suggests secondary performance improves with later start times. However, a later start time would not allow, at this time, the task force to accomplish the stated goal of fiscal management. The district continues to evaluate current research studies and literature involving various pro-active educational practices.
- 3. <u>Parents are concerned about the safety of the bus stop, which could be too dark or too dangerous.</u>
  - a. Utilizing state guidelines and district policies, the Transportation Department evaluates the safety and appropriateness of all bus stops. Any families who have concerns about their bus stops should contact the Transportation Department.
- 4. Parents are concerned that the proposed change will impact their after school child care.
  - a. Although the district will not provide child care for middle school students, the earlier dismissal time will allow us to potentially expand our existing after school homework assistance program. The Fugett ASAP (After School Academic Program) could be expanded to include various student assistance areas. Opportunities also exist to expand other after school programming.

- 5. <u>Parents are concerned about traffic pattern issues that they believe will occur on the Fugett/East campus due to an increase in the number of parents that will drive their children to and from school.</u>
  - a. Please see the dismissal and arrival information and map contained in question 10. under "Other Questions" section below.
- 6. Parents are concerned that Fugett Middle School is the only middle school impacted by the proposed change.
  - a. Fugett and East sit on the same campus. No other middle school is close enough to a high school to allow the same kind of time savings. The task force committee did examine combining Stetson and Sarah Starkweather, but the timing and number of buses did not work with creating the fourth bell time and doubling up buses at different elementary schools. Combining Fugett and East, using the high school bell times, basically allowed us to create a fourth bell tier for 4 elementary schools in the same time slot we would normally have taken home Fugett students and still be done early enough to get to the other 6 elementary schools with minor changes at that level.
- 7. A parent was concerned that we do not provide extra-curricular bussing which the parent believed may be needed due to the proposed change.
  - a. The proposed plan will not require adding additional buses to ensure that students access their extra-curricular activities. In fact, the student day will end at 2:15 p.m. All students who are in a teacher/coach supervised activity will locker and/or change as required and report to their assigned location as communicated by the athletic director/coach or activity sponsor. Any student who is not in a teacher supervised activity and may wish to be a spectator of that athletic competition or activity should report to that location i.e. Gymnasium, Stadium, Auditorium, etc. Adequate teacher supervision will be organized as follows: Teacher duty assignments will be re-allocated. Teacher duty assignments during the day may include hall duty, cafeteria duty, internal suspension, etc. A rotating teacher duty assignment for afternoon coverage will be created. Teachers will either have a day duty coverage or may be assigned an afternoon duty coverage. This schedule will be developed based on the student sports and activities schedule. The event and the number of students potentially attending that event will be considered.

# Conclusion:

The categories that emerged from the feedback forms and emails matched the concerns that were expressed during our public informational sessions. Additionally, the administration and Transportation Committee elicited other potential issues and concerns that are listed in the Q&A section below.

# OTHER QUESTIONS & ANSWERS ON SECONDARY SCHOOL BELL TIME CHANGE

# 1. How will Sports/Extra Curricular Activities be impacted/managed at Fugett Middle School?

# **Student Supervision**

The student day ends at 2:15 p.m. All students who are in a teacher/coach supervised activity will locker and/or change as required and report to their assigned location as communicated by the athletic director/coach or activity sponsor. Any student who is not in a teacher supervised activity and may wish to be a spectator of that athletic competition or activity should report to that location i.e. Gymnasium, Stadium, Auditorium, etc. Adequate teacher supervision will be organized as follows: Teacher duty assignments will be reallocated. Teacher duty assignments during the day may include hall duty, cafeteria duty, internal suspension, etc. A rotating teacher duty assignment for afternoon coverage will be created. Teachers will either have day duty coverage or may be assigned an afternoon duty coverage. This schedule will be developed based on the student sports and activities schedule. The event and the number of students potentially attending that event will be considered.

# **After-school Programming**

The 2:15 p.m. to 2:50 p.m. time will include expansion of our existing after school homework assistance program. The Fugett ASAP (After School Academic Program) could be expanded to include various student assistance areas. Opportunities exist to expand other after school programming.

All standing committees such as Team Leaders, Dept. Chairs, Data-Analysis teams, etc. will move from 7:30 a.m. times to 2:15 p.m. time slot. The same day cycle of Tues/Wed will be maintained. This time may also be utilized for additional staff development as needed.

# 2. How will the district manage buses without overcrowding?

Currently 18 buses are used to transport students to and from Fugett. With the new plan, approximately 32 buses will be used to transport Fugett and East together. 30 – 35 middle school students and 20-25 high school students will be assigned to each bus for a total of 55 - 60 assigned students to each bus. Only 60% of the assigned high school students ride on a daily basis on most routes. All buses are equipped with digital cameras which are used to monitor everything from student behavior to ridership levels. Adjustments will be made for cases of actual bus overcrowding

# 3. Will this impact Fugett early dismissal schedule?

Fugett will follow the same early dismissal schedule as Peirce &Stetson. This will remain consistent with past practice with an added benefit of an additional ½ hr. of instruction. Weather emergency early dismissal will require East & Fugett to dismiss at the same time.

# 4. Will my high school student be permitted to transport his middle school sibling?

Yes- arrangements can be made by speaking with the Fugett Administration.

# 5. Can staff request a transfer to a different building based on changes made to building bell schedules?

As part of the staffing process for the 2011-2012 school year, the District will certainly consider any staff member's request to be reassigned to a different building based on

building bell schedule changes which result from the new Transportation plan. In order to receive consideration staff should complete the "Request to Transfer Form" available on the District website at: www.wcasd.net/admin/transfer\_requests.asp

Please note the deadline for form submission is April 1st, and any preferences by staff for a specific building(s) may limit the District's ability to find the requested placement.

6. The middle schools currently share a number of teachers. When Fugett changes to the high school bell schedule, how will this impact the workday schedules for these teachers?

When the students and teachers are scheduled for the 2011-12 years, extra care will be taken to minimize the number of teachers that are shared between Fugett Middle School and our other two Middle Schools. There may be some opportunity to share teachers between East High School and Fugett Middle School as well.

# 7. How will drop off and loading look at the East/Fugett Complex?

# <u>Arrival</u>

Upon arrival students will be grouped by grade into the following locations:

6<sup>th</sup> Grade- Auditorium

7<sup>th</sup> Grade- Cafeteria

8<sup>th</sup> Grade-Gymnasium

6<sup>th</sup> Grade will be supervised by the 6<sup>th</sup> grade administrator and two teachers

7<sup>th</sup> Grade will be supervised by the 7<sup>th</sup> grade administrator and two teachers 8th grade will be supervised by the 8th grade administrator and two teachers. Students will not be permitted into the grade level floors without a teacher note. Once the warning bell rings at 7:25 a.m., students will then be permitted to move to home room. Homeroom will be from 7:30 a.m. to 7:40 a.m. 1st period will begin at 7:43 a.m.

# **Departure**

At the end of the school day, at 2:15 p.m., students will remain in their 8<sup>th</sup> period class. Two groupings of busses, Group A and Group B will occur. Group A will be loading at East High School and Group B will be loading at Fugett Middle School. Students will be called by group. The bus groups will then rotate and the opposite group will load.
