## **Infinite Campus Parent Portal Agreement**

Infinite Campus offers parents real-time access to grades, attendance, and class information. You can e-mail teachers or ask for automatic updates on your child's progress. All information about your child is secure and available only to you.

An Internet connection is the only requirement needed. The Infinite Campus Parent Portal program works best when using the Google Chrome or Microsoft Edge browser. The Infinite Campus Parent Portal is on the Georgia School for the Deaf website. The link is <a href="https://www.gsdweb.org/">https://www.gsdweb.org/</a>

In order to access the Parent Portal, the following <u>Acceptable Use Policy</u> must be met. Once Georgia School for the Deaf (GSD) receives signed confirmation of the Parent Portal's Acceptable Use Policy, the **Username** and Temporary **Password** will be provided for access to the Portal. After you log in for the first time, please change your password.

## Acceptable Use Policy

Technology Resources as defined in the GaDOE Acceptable Use Guidelines for Technology Resources, State Schools:

The State Schools' computer system and networks are any configuration of hardware and software. The systems and networks include all of the computer hardware, operating system software, application software, stored text and data files. This includes electronic mail, local databases, externally accessed databases (such as the internet), CD-ROM, optical media, clip art, digital images, digitized information, communication technologies, and new technologies as they become available. (Reference: Acceptable Use Guidelines for Technology Resources, State Schools, SS-4003).

A *one-time* agreement must be made to abide by the guidelines set forth. Violation of any guideline may result in permanent removal from the Parent Portal.

- Only the legal parent(s)/guardian(s) of the student or student (ages 18 and up) will have access availability to the student's information.
- The accuracy of a student's information is a shared responsibility among GSD, legal parent(s)/guardian(s) and students.
- GSD maintains the rights to add, modify or delete information and Portal functions at any time, as well as the right to deny legal parent(s)/guardian(s) access with suitable cause.
- GSD suggests <u>not</u> setting your computer to automatically sign in with regard to username and password. It is also best for each legal parent/guardian to have an individual account rather than a household account.
- Use of the Portal is subject to electronic monitoring by GSD, as well as other specific rights GSD
  maintains.
