4. Evaluating the effectiveness of the SPSA
5. Revising the Home–School Compact and Parent Involvement Guidelines, annually
6. Review, revise, and approve the School Safety Plan
7. Revising School Site Council By–laws annually and post on your website
8. The Board of Trustees holds the final authority.


English Learner Advisory Committee (ELAC)
