Thank you for your unwavering support, and I look forward to the exciting journey that lies ahead.

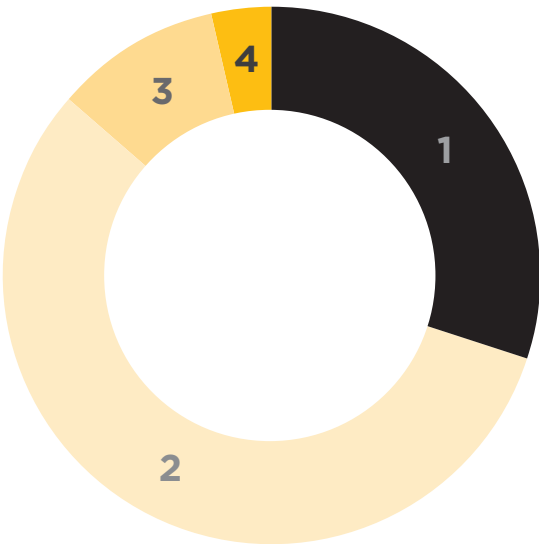
