Describe your work and volunteer background and how it prepares you to be a member of the school board.

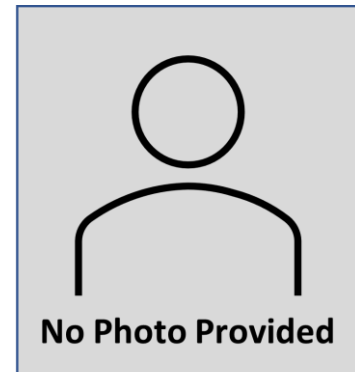
