



## OUR LADY OF THE LAKE SCHOOL 2025-2026 TUITION AND FEE AGREEMENT

Please take a moment to read the fee agreement information and sign below indicating you understand and accept the terms of the Tuition and Fee Agreement with Our Lady of the Lake School for the 2025-2026 school year. Then select one of the payment options advising the financial administrator of your intent. If financing for the first time is the option you choose, please complete the parent name and address information.

1. A registration fee of \$150 for each student is due at the time of registration. Should your child(ren) be accepted into OLL, the registration fee is non-refundable. The *Clarion Herald* fee of \$15 (all grade levels) will be paid on a per family basis and is also due at the time of registration.
2. See additional information sheet for definitions of the fee categories for all grade levels. Please note that the security fee is due by April 17, 2025. Also, the support fee, should it apply, is due by April 17, 2025.
3. The school administration may require a student to stay out of school if the tuition or fee payments are not made according to the terms listed herein and in the financing document.
4. There will be a \$25 processing fee for all loans canceled by the parent.
5. There will be a \$25 per student fee for any student withdrawn during the school year.
6. Tuition Financial Form and Statement will be mailed to parents in March of 2025.

Select one of the two payment options:

A. \_\_\_\_\_ I agree to make lump sum payment to the financial administrator by the deadline of April 17, 2025, for the total amount of tuition as shown on the Tuition Financial Form and Statement.

B. Gulf Coast Bank is offering Our Lady of the Lake families a Tuition Financing Program at the rate of 10.75% for those who wish to finance the tuition over 10 months (July 2025 through April 2026). The ten monthly payments are due on either the 1<sup>st</sup> or the 15<sup>th</sup> of each month. Payments made after the designated date each month will be assessed a late fee. Should a parent not be able to make a payment by the last day of the month, they must contact the school financial administrator to discuss the situation. The bank will cancel the loan of any individual who has not made a payment within a time specified by the bank. If the bank cancels the loan, the remainder of the current year's tuition **becomes due immediately and is payable directly to the school.** ([www.tuition.gulfbank.com](http://www.tuition.gulfbank.com))
