WHEREAS, the Board of Education, after careful consideration, has determined that Dr. Jeffrey Bryant possesses the experience and necessary qualifications to serve as the Remsen Central School District's Interim Superintendent of Schools/Elementary Principal so as to assist in the efficient operation of the District and to continue the orderly administration of the District's ongoing programs and projects while it conducts a search for, and until the effective appointment date of, its new Superintendent of Schools/Elementary Principal; and

WHEREAS, Dr. Bryant has agreed to accept the Board's offer of appointment to serve as the Interim Superintendent of Schools/Elementary Principal effective January 1, 2017.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby appoints Jeffrey Bryant as the Interim Superintendent of Schools/Elementary Principal of the Remsen Central School District for a term commencing on or about January 1, 2017 through on or about June 30, 2017, or until a new Superintendent of Schools/Elementary Principal is hired, whichever comes first, during which he shall be compensated on a *per diem* basis of \$600/day for services rendered; and

BE IT FURTHER RESOLVED that the Board of Education hereby appoints Jeffrey Bryant as a paid consultant to the District on an as needed basis as determined by Dr. Crankshaw, on a per diem basis of \$600/day for the purpose of transition planning between December 15 and December 31, 2016, not to exceed three (3) days; and

BE IT FURTHER RESOLVED that this appointment shall be memorialized in a written agreement of the parties containing all of the relevant and applicable benefits, terms and conditions of employment for the Interim Superintendent/Elementary Principal, subject to Board of Education review and approval." Unanimous vote
