High School Principal's Report given by Sanya Pelrah included the following items:

- Team Workshop held on April 4th where focus was on team building and continuing our circle work with a focus on maintaining positive relationships with students.
- High School Instructional Committee currently collecting information and discussing ways to bring more consistency to our grading practices.
- 7th and 8th Grade Science Fair held on March 9th was a success. 13 students moving on to the Regional Science Fair at Utica University.
- Senior Switch Day held on March 15th. Grades 5-12 Band and Chorus Concert held on March 16th. National Honor Society held induction ceremony on March 24th.

Student Council President, Abby Barton, reported there will be a blood drive on May 5th. There will be an "Easter Egg Scavenger Hunt" the week after spring break.

Elementary Principal's Report given by Gary Winghart included the following items:

- Boonville Elks Club donated bicycle helmets for all our Kindergarten students. On April 8th, students will participated in a bicycle safety lesson and will be presented with a bike helmet to take home. Thank you to Boonville Elks for their generous donation.
- Grades 3-8 NYS ELA Assessments This year all students in grades 3-6 took assessment online using NYS computer based testing platform.
- Evening of Excellence held on March 28th.
- Promethean Board Training held on March 18th. Two Education Consultants from Promethean provided professional development for our staff on the use of the new boards.
- Rock Climbing in PE Students have spent the last few weeks rock climbing in PE with Mr. Jones. Students are provided with the opportunity to learn and strengthen climbing, jumping and tumbling skills.

Dale Dening gave his Athletic Director's Report which included the following:

- April 4th Modified Spring Sports Practices begin
- Coaching Appointments Jim Wilder-Varsity Baseball; Michele Izzo-Modified Softball and Dan O'Bryan-Girls Varsity Track & Field
- No modified baseball offered this year due to low interest

Facilities Report given by Kevin Roberts included the following:

- Capital Improvement Project Phase IIB Scope of work will be the high school stage curtains and rigging. R. Alexander Construction of Marcy NY was low bidder and are tentatively set to begin over April break.
- 2022 Capital Outlay Project Renovation of old JSHS Boys' locker room into storage room and SED approved vault Construction begin February 22nd. Demolition at 80%. Contractors not onsite since February break. Project must be completed by June 30th.
- 2023 Capital Outlay Project Plan is to replace student lockers in the elementary intermediate wing. Flooring will be replaced in several areas that were not done in the last capital project.
- SED Building Condition Surveys Walk-throughs of all buildings completed. Still need to conduct roof area and grounds inspections.

Transportation Report given by Adam DeGrace included the following:

- Inspections done on buses 89, 97, 98 all passed
- Bus Fleet Update Bus 88 removed from service as it is consuming oil and corrosion is getting worse. This bus is being replaced. Too costly to repair.
- Bus drivers current on qualifications. Yearly physicals completed.

- 2. The Board hereby determines the Proposed Action as a Type II action in accordance with the SEQRA regulations.
- 3. No further review of the Proposed Action is required under SEQRA.

BE IT FURTHER RESOLVED, that the Board of Education of the Central School listed below authorizes the Delaware-Chenango-Madison-Otsego BOCES to represent it in all matters leading up to the entering into a contract for the purchase of the above mentioned commodities, and,

BE IT FURTHER RESOLVED, that the Board of Education of the Central School listed below agrees to (1) assume its equitable share of the costs of the Cooperative Bidding; (2) abide by majority decisions of the participating districts; (3) abide by the Award of the BOCES Board; (4) and that after the award of the bid it will conduct all negotiations directly with the successful bidder(s).
