Message from the Superintendent

Dear Remsen Community,

Genuinely good, hard-working people make Remsen a very special place to live, learn and work. Collectively, we understand that our goal must always be to ensure that we leave our children, for generations to come, with an even better community and school than we had. This is accomplished by continuing to work together to help cultivate our Remsen community and by providing our children the ability to receive an innovative education, full of diverse learning opportunities and experiences. The level of support that our students receive from every District resident is appreciated beyond words. Even if you currently do not have students enrolled in school, your support of Remsen Central School plays a critical role in raising, teaching and growing our youth into productive, responsible, kind, hard-working citizens. It truly does make a difference.

We have been hard at work preparing our Student Opportunities Plan (proposed budget) for the 2022-2023 school year. Thoughtful planning and monthly work sessions enabled our team to develop a fiscally responsible budget, responsive to our students' needs, with only a slight tax levy increase of 1%. This increase is below our allowable New York State Property Tax Cap levy increase limit and reflects our commitment to balance the needs of our school district with the challenges that we, as a society, are currently living.

In addition to voting on the proposed 2022-2023 budget in the amount of \$13,986,284, we will also be voting on the purchase of two 66-passenger school buses. The proposed purchase is part of an ongoing bus replacement plan designed to keep the District's fleet in safe, working order by phasing out buses that are no longer cost effective to maintain. If the proposition is approved, the actual cost to the District will be significantly less than the amount sought. Approximately 80.4% of the cost would be reimbursable through state aid.

Our budget hearing will take place on Tuesday, May 10 at 6:00 p.m. in the elementary library media center. Please consider joining us to learn more about our Student Opportunities Plan and to hear from our one Board of Education candidate seeking reelection. If you are unable to attend, the full presentation will be posted to our webpage shortly thereafter. Additional budget and Board of Education election information may also be found throughout this newsletter. Please do not hesitate to reach out to me if you have any questions.

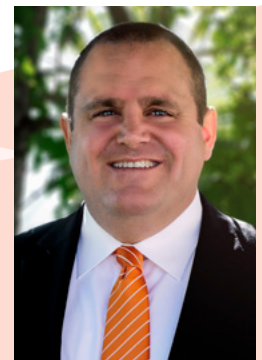
Our school budget vote will take place on Tuesday, May 17, from 1:00 p.m. until 8:00 p.m. in the elementary cafeteria. Voter parking spaces will be reserved at the front of the elementary parking lot closest to the cafeteria doors. Back by popular demand, our FFA students will be selling plants outside of the cafeteria doors starting at 3:00 p.m.

Who Can Vote?

To be eligible to vote, a resident must have lived in the Remsen Central School District for at least 30 days prior to the May 17 election, be at least 18 years of age, a citizen of the United States and registered to vote with the school district. No person shall have the right to register for or vote who would not be qualified to register for or vote at an election in accordance with the provisions of section 5-106 of the Election Law.

Can I Vote by Absentee Ballot?

Residents who will not be in the area on May 17, or who are unable to vote in person (including for COVID-19 related reasons), may apply for an absentee ballot at the Remsen Central School District Office. If the absentee ballot is to be mailed to the voter, the application must be submitted at least seven days prior to the vote. If the absentee ballot is to be picked up by the voter in person, applications will be accepted until May 16. Absentee ballots must be returned to the district clerk no later than 5:00 p.m. on May 17.

Propositions on the Ballot

2022-2023 BUDGET PROPOSITION

RESOLVED, that the 2022-2023 budget for the Remsen Central School District, in the amount of \$13,986,284, is hereby adopted and the requisite portion thereof is to be raised by taxation on the taxable property of the District.

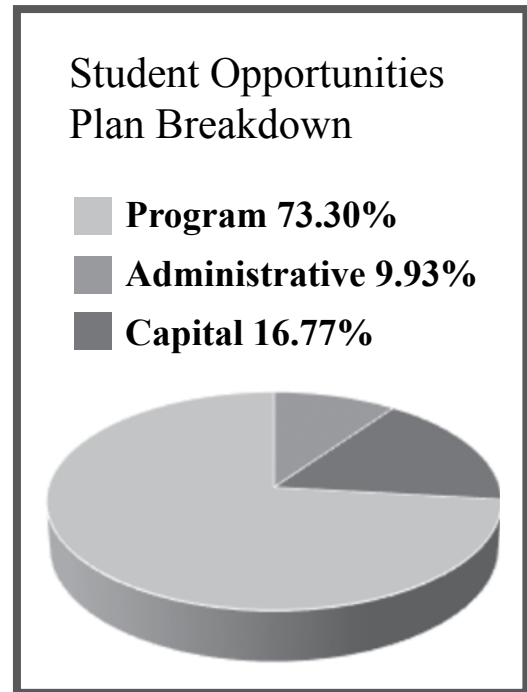
Proposition #1 - Bus Purchase

RESOLVED, that the Board of Education of the Remsen Central School District is hereby authorized to undertake the acquisition of two 66-passenger school buses, not to exceed estimated maximum cost of \$253,018 less trade-in value, if any, and that such costs, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments. In anticipation of such tax, debt obligations of the school district as may be necessary not to exceed \$253,018 shall be issued, or the school district may enter into an installment purchase contract if the Board of Education determines that it is in the best interest of the school district to finance the purchase in that method.

Replacement of all lockers in the intermediate wing of the elementary building.

NO ADDITIONAL FINANCIAL IMPACT TO THE COMMUNITY

Anticipated start – Spring 2023

The proposed 2022-2023 Remsen Central School District budget includes a \$100,000 Capital Outlay Project. It is important to note that the Remsen Central School District will be reimbursed by the state for 83.5% of the Capital Outlay Project's cost. In other words, a \$100,000 project only costs the District \$16,500.

The proposed project for next year will be to replace all of the deteriorated lockers in the elementary intermediate wing, including soffit, base and paint work. The replacement of flooring in several elementary rooms is also included in this project proposal.

One of our overarching goals for the Remsen Central School District is to continue to provide safe, efficient and operational facilities for our students and our community members. Capital Outlay Projects allow us to responsibly make necessary improvements without placing a large burden on the community.

100 DAYS OF SCHOOL

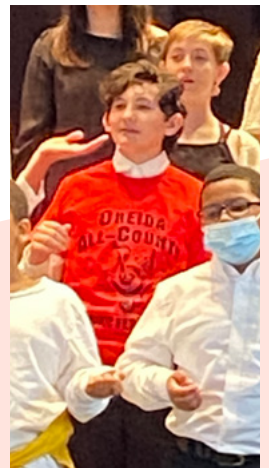
On February 15, Remsen elementary students celebrated the 100th day of school by dressing like they were 100 years old, wearing 100 of something or representing 100 in another way!

The valentines were distributed to local healthcare facilities as a way to say thank you to the doctors, nurses and other healthcare staff.



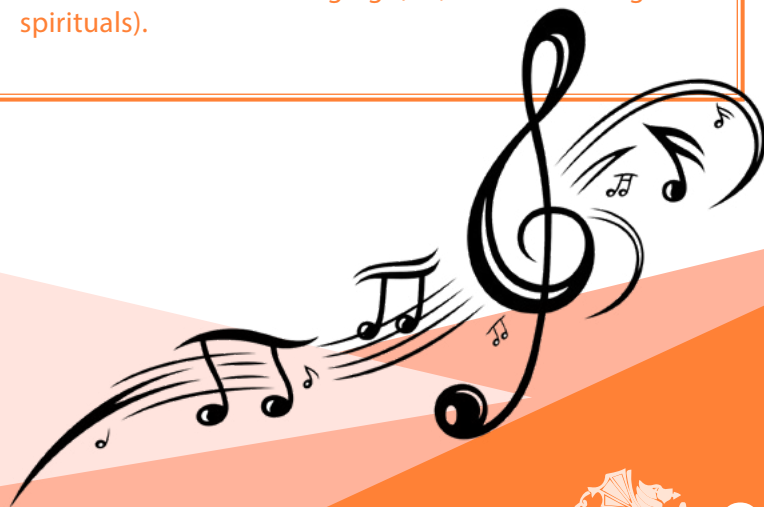

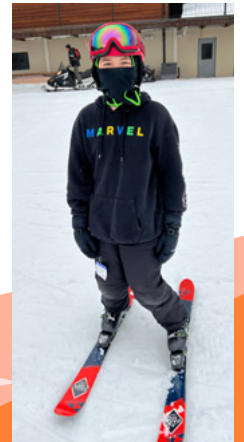
ALL-COUNTY *Festival*

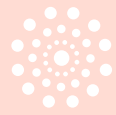

ALL KIDS BIKE

With spring on its way, we are excited to announce that the All Kids Bike Program will be introduced into our physical education curriculum thanks to a very generous donation from the Edwin J. Wadas Foundation. The All Kids Bike Program includes a Strider 14x bike for each child in the physical education class. This two-in-one balance-to-pedal conversion bike helps riders gain confidence and learn more advanced skills on a balance bike. When children are ready, it easily transforms into a pedal bike with the installation of the easy-ride pedal conversion kit. The program includes teacher training and certification, an eight-lesson learn-to-ride curriculum, a fleet of two-in-one balance-to-pedal conversion bikes, fully adjustable bicycle helmets and five years of program support. The provided curriculum is designed with the simple goal of teaching a child how to move, balance and stop while on a two-wheeled balance bike. About midway through the curriculum, there is the option to easily convert the bikes from balance-mode to pedal-mode as students are ready to progress to pedaling the bike.

We are very excited to be able to provide our kindergarten students this opportunity, beginning with our current kindergarten students this spring. We would like to thank Mrs. Eilleen Hamlin and Mr. Scott Jones for their work in bringing the program to Remsen and of course a big thank you to the Edwin J. Wadas Foundation for making this possible for the students of Remsen Elementary.

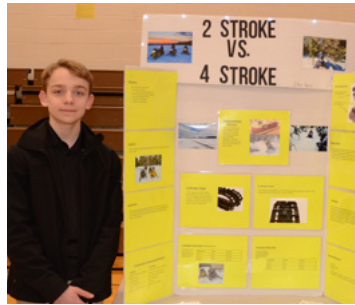

MMM

Several RCSD students participated in a National MathWorks Math Modeling (M3) Challenge on February 28.

This year, their problem was titled "Remote Work: Fad or Future." Students were given data about remote work, starting as early as the year 2000, as well as data about the overall increase in the trend toward remote work over the next two decades. During the height of the COVID-19 pandemic, remote work saw a massive spike, but as COVID-19 restrictions were lifted, the world returned to work. The students were tasked with finding a model that would predict what remote work would look like for the future and apply their models to the years 2024 and 2027. They also needed to consider different regions of the United States and United Kingdom, and how remote work would affect these areas. Specifically, they needed to consider a highly urban area (Seattle, WA), a semi-urban area (Scranton, PA) and a rural area (Liverpool, England).

Their second task was to consider workers who choose to work from home and compare them to workers whose employer permits them to work from home. They needed to create a model that predicts whether an individual worker whose job is remote-ready will be allowed to and choose to work from home.

Their last task was to synthesize both of their models and estimate the percentage of workers who will work remotely in the above mentioned cities for the years 2024 and 2027.

Teams were given 14 hours and the RCSD team submitted their solution with only one minute left on the clock. Their solution was a total of 14 pages, however, the team unfortunately did not advance to the next round.

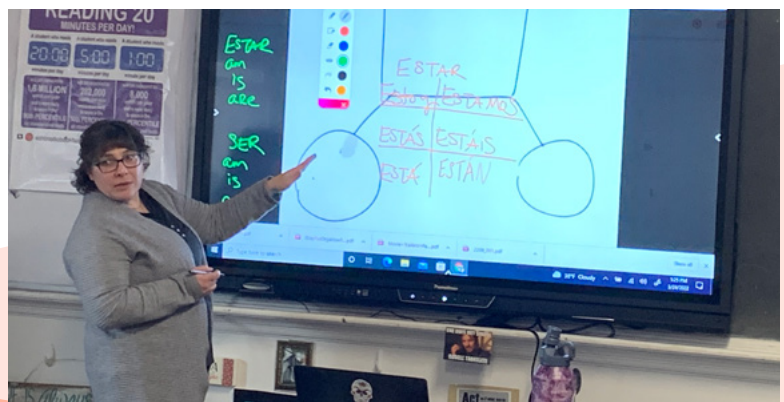
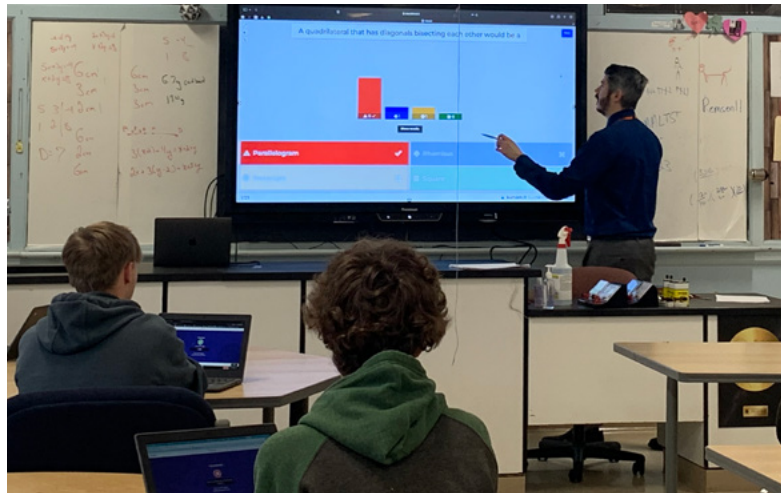
New PROMETHEAN BOARDS

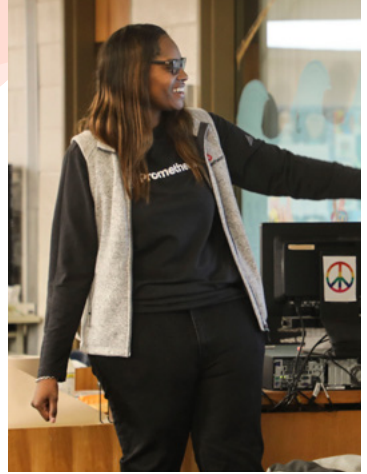
The Remsen CSD recently installed brand new Promethean Boards, District-wide and in all classrooms!
